10 **A RESOLUTION**

11 **ESTABLISHING A CITY COOPERATIVE PROGRAM WITH THE NEW MEXICO**  
12 **DEPARTMENT OF TRANSPORTATION.**

14 **WHEREAS**, the City of Santa Fe plans to make roadway improvements to Don Gaspar  
15 Avenue as part of it's annual Resurfacing Program, from West San Francisco St. to West  
16 Alameda; and

17 **WHEREAS**, funding assistance will be provided upon execution of a Local Government  
18 Road Fund (LGRF) Cooperative Agreement between the New Mexico Department of  
19 Transportation (NMDOT) and the City of Santa Fe; and

20 **WHEREAS**, the improvements to Don Gaspar Avenue shall include roadway pavement  
21 rehabilitation; drainage and pedestrian improvements to include reconstruction of some  
22 deteriorated curb and gutter as well as sidewalks, manhole adjustments and ADA curb ramp  
23 installations; and

24 **WHEREAS**, the improvements to Don Gaspar Avenue shall enhance roadway and  
25 pedestrian safety by improving ride ability; and

1           **WHEREAS**, funding to aid in construction shall consist of \$52,136.00 through a LGRF  
2 Cooperative Agreement with the NMDOT; and

3           **WHEREAS**, the City, as part of the LGRF Cooperative Agreement, shall match up to  
4 \$17,378.67 (25% Share), to NMDOT funds of up to \$52,136.00 (75% Share); and

5           **WHEREAS**, the City shall assume ownership, liability and maintenance responsibilities  
6 for all amenities related to the completion of the project.


7           **NOW THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE**  
8 **CITY OF SANTA FE** that City staff are directed to bring forth a project agreement with the  
9 State of New Mexico to share in the funding for improvements to Don Gaspar Avenue.




