11	APPROVING PARTICIPATION IN THE PROGRAM OF THE NORTH CENTRAL
12	NEW MEXICO ECONOMIC DEVELOPMENT DISTRICT.

14	WHEREAS, the City of Santa Fe is a member of and desires to continue participation in
15	the North Central New Mexico Economic Development District (NCNMEDD), which was
16	created June 27, 1967, by statutory authority of the Joint Powers Agreement Act for the purpose
17	of assisting local governments in developing and implementing Regional Economic Development
18	Programs; and
19	WHEREAS, in accordance with the Joint Powers Agreement, it is necessary and
20	desirable that reasonable assessments be paid to the NCNMEDD for the purpose of participating
21	in private sector, state and federal programs affecting the region; and
22	WHEREAS, the NCNMEDD has furnished and will continue to furnish technical
23	assistance, project review, in accordance with EO 12372 Intergovernmental Review and
24	Coordination (NMIRC), planning coordination, management and other assistance directed toward
25	implementing planning, community and economic development programs; and

1	WHEREAS, it is the intention of the City of Santa Fe to remain a voting member of the
2	NCNMEDD and participate in policy development administration; and
3	WHEREAS, in accordance with the Joint Powers Agreement, the City of Santa Fe
4	desires to continue eligibility for participating localities under Section 302 of the Public Works
5	and Economic Development Act of 1965, as amended or any other federal, state or private sector
6	programs; and
7	WHEREAS, the City of Santa Fe elects not to prepare an Annual Report of its own and
8	instead adopts the District's Annual Report and Overall Economic Development Program as its
9	own to be submitted to any programs that requires it.
10	NOW, THERFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE
11	CITY OF SANTA FE that the City of Santa Fe remain a member of the NCNMEDD and pay as
12	its annual assessment for the fiscal year 2007/2008 into the treasury of the NCNMEDD the sum
13	of two thousand one hundred dollars (\$2,100) as payment for all services rendered by the
14	NCNMEDD during said fiscal year.
15	BE IT FURTHER RESOLVED that the City of Santa Fe hereby concurs in the
16	NCNMEDD Annual Report and its current Overall Economic Development Program, such
17	concurrence to be effective until otherwise rescinded, and the NCNMEDD and the state, federal
18	or private sector programs be notified.
