**SUPPORTING THE NAMING OF FIELD #2 AT FRANKLIN E. MILES PARK IN HONOR OF CHARLIE "THE GREEK" GRIEGO.**

**WHEREAS,** Charlie "the Greek" Griego ("Charlie") was active in community affairs all of his life; and

**WHEREAS,** Charlie worked for the city of Santa Fe for 25 years; and

**WHEREAS,** Charlie coached little league baseball in Santa Fe for numerous years; and

**WHEREAS,** Charlie was an outspoken advocate for neighborhoods and the disadvantaged in the halls of city government; and


**WHEREAS,** Charlie's efforts on behalf of his community resulted in Sunday bus service, the Maez Road drainage project, the 3-way stop sign on Maez Road and Rosina Street, the no-parking zone on Maez Road and numerous other traffic and public safety improvements; and

**WHEREAS,** through Resolution No. 2003-56 the governing body resolved to memorialize Charlie Griego by naming or dedicating an appropriate public facility to his

1 memory.


2 **NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE**
