



10 A JOINT RESOLUTION

11 HONORING THE MEMORY OF SARAH WILLIAMS; NAMING A TRAIL IN THE  
12 COUNTY OF SANTA FE'S TRAIL SYSTEM FOR HER.

13  
14 WHEREAS, the community of Santa Fe suffered a great loss on March 31, 2007 with  
15 the death of Sarah Williams to a senseless, alleged drunken-driving accident; and

16 WHEREAS, Sarah's deep love for humanity and nature was shown throughout her life  
17 in her words and actions; and

18 WHEREAS, Sarah supported her many friends with her big heart, generosity and infinite  
19 patience as well as countless nonprofit organizations in New Mexico with her time, talent and  
20 resources; and

21 WHEREAS, Sarah became an environmental activist in recent years and was tireless in  
22 her efforts to save our environment and specifically to preserve the forests on our community-  
23 owned lands; and

24 WHEREAS, Sarah was an avid hiker and enjoyed our local trail system; and

25 WHEREAS, the County of Santa Fe is currently in the process of developing a three

1 mile trail beginning at the last Dale Ball trailhead on the south side of Hyde Park Road and  
2 connecting to the Little Tesuque Creek Trail; and

3 **WHEREAS**, the residents of Santa Fe County approved a general obligation bond in  
4 1998 establishing funding for the "Wildlife, Mountains, Trails and Historic Places Program"; and

5 **WHEREAS**, development of workplace skills for our youth is integral to the  
6 community's economic and social wellbeing; and

7 **WHEREAS**, both the City of Santa Fe and Santa Fe County have successfully included  
8 youth conservation corps programs on other trail and outdoor projects.

9 **NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY**  
10 **COMMISSIONERS OF SANTA FE COUNTY AND THE GOVERNING BODY OF THE**  
11 **CITY OF SANTA FE, AS FOLLOWS:**

12 1. The Governing Body of the City of Santa Fe wishes to honor the memory of  
13 Sarah Williams and recommends to the Board of County Commissioner of Santa Fe County that  
14 the three mile trail beginning at the last Dale Ball trailhead on Hyde Park Road and connecting to  
15 the Little Tesuque Creek Trail be named in her honor. The Governing Body sincerely appreciates  
16 the Board of County Commissioners' consideration of naming the county trail in honor of Sarah  
17 Williams.

18 2. The Board of County Commissioners of Santa Fe County wishes to honor the  
19 memory of Sarah Williams and hereby names the three mile trail beginning at the last Dale Ball  
20 trailhead on Hyde Park Road and connecting to the Little Tesuque Creek Trail the "Sarah  
21 Williams Trail".

22 3. The respective City and County staffs, responsible for trail planning, are directed  
23 to collaborate in order to accomplish this trail in a timely manner.

24 4. The involvement of youth conservation corps programs in building the Sarah  
25 Williams Trail is appropriate and will be initiated.

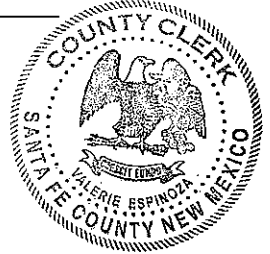
