



10 A RESOLUTION

11 ORGANIZING A WORKING GROUP TO MAKE RECOMMENDATIONS TO THE
12 GOVERNING BODY REGARDING POLICIES AND PROCEDURES, MANAGEMENT,
13 MAINTENANCE AND OPERATIONS, AND BUDGET FOR THE RAILYARD PARK,
14 PLAZA AND ALAMEDA.

16 WHEREAS, the railyard plan includes a public park, plaza and alameda that will serve
17 as an active public gathering place for the community; and

18 WHEREAS, the park, plaza and alameda are located within the conservation easement
19 that is monitored by the Trust for Public Land; and

20 WHEREAS, the Governing Body adopted Resolution No. 2006-110 on September 13,
21 2006; and

22 WHEREAS, such resolution directed the City Manager and City Staff to develop
23 policies and procedures for the city owned or controlled land in the railyard; and

24 WHEREAS, over the last three months city staff, the Santa Fe Railyard Community
25 Corporation, the Trust for Public Land and representatives of the 2001 City of Santa Fe Railyard

1 Master Plan Team have been meeting informally to discuss the Railyard Park, Plaza and
2 Alameda; and

3 **WHEREAS**, such organizations have pre-existing contractual relationships with the City
4 of Santa Fe for the design and management of the Railyard Park, Plaza and Alameda.


5 **NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE**
6 **CITY OF SANTA FE** that city staff is directed to act as the liaison and organize this working
7 group of city staff, the Santa Fe Railyard Community Corporation, the Trust for Public Land and
8 ex-officio representatives of the 2001 City of Santa Fe Railyard Master Plan Team.

9 **AND BE IT FURTHER RESOLVED** that such working group shall make
10 recommendations to the Governing Body regarding the Santa Fe Railyard Park, Plaza and,
11 Alameda (as defined in the Deed of Conservation Easement) to include but not be limited to:

- 12 1. Policies and procedures for the use of the Park, Plaza and Alameda;
- 13 2. Management;
- 14 3. Maintenance and operations; and
- 15 4. Budget.

16 **AND BE IT FURTHER RESOLVED** that in order to be consistent with the action
17 taken by the governing body on January 10, 2007, regarding the approval of the request from the
18 Santa Fe Farmers' Market for use of the Railyard Plaza and Alameda, the working group shall
19 meet and act upon the request by the Farmers' Market within 30 days of the passage of this
20 resolution.




