10 A RESOLUTION

11 ESTABLISHING A CITY COOPERATIVE PROGRAM WITH THE NEW MEXICO
12 DEPARTMENT OF TRANSPORTATION.

14 WHEREAS, the City of Santa Fe plans to make roadway improvements to Galisteo
15 Street as part of it's annual Resurfacing Program, from San Mateo to Cordova Road; and

16 WHEREAS, funding assistance will be provided upon execution of a Local Government
17 Road Fund (LGRF) Cooperative Agreement between the New Mexico Department of
18 Transportation (NMDOT) and the City of Santa Fe; and

19 WHEREAS, the improvements to Galisteo Street shall include roadway pavement
20 rehabilitation; drainage and pedestrian improvements to include reconstruction of some
21 deteriorated curb and gutter as well as sidewalks, manhole adjustments and ADA curb ramp
22 installations; and

23 WHEREAS, the improvements to Galisteo Street shall enhance roadway and pedestrian
24 safety by improving ride ability and sidewalks; and

25 WHEREAS, funding to aid in construction shall consist of \$59,482.85 through a LGRF

1 Cooperative Agreement with the NMDOT; and

2 **WHEREAS**, the City, as part of the LGRF Cooperative Agreement, shall match up to
3 \$19,827.62 (25% Share), to NMDOT funds of up to \$59,482.85 (75% Share); and

4 **WHEREAS**, the City shall assume ownership, liability and maintenance responsibilities
5 for all amenities related to the completion of the project.


6 **NOW THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE**

8 State of New Mexico to share in the funding for improvements to Galisteo Street

9 **PASSED, APPROVED and ADOPTED** this 10th day of January, 2007.


