CITY OF SANTA FE, NEW MEXICO 1 **RESOLUTION NO. 2011-14** 2 INTRODUCED BY: 3 4 5 Councilor Ortiz 6 7 8 9 A RESOLUTION AMENDING RESOLUTION NO. 2010-79 TO INCLUDE THAT THE COUNTY OF SANTA 10 FE WILL PROVIDE FUNDING, ALONGSIDE THE CITY OF SANTA FE AND THE STATE 11 OF NEW MEXICO, FOR THE SPANISH STATE VISIT, THE MEXICAN PRESIDENTIAL 12 VISIT AND CLOSING CEREMONIES, EVENTS PLANNED BY SANTA FE 400^{TH} 13 14 ANNIVERSARY, INC., UPON CERTAIN CONDITIONS. 15 WHEREAS, the Governing Body of the City of Santa Fe adopted Resolution 2010-79 to 16 approve funding in the amount of \$20,000 to assist Santa Fe 400th Anniversary, Inc. for the 17 Spanish State visit and the Mexican Presidential visit; and 18 WHEREAS, the Governing Body adopted Resolution No. 2007-59 reestablishing the 19 Santa Fe 400th Anniversary Committee which became a nonprofit organization, Santa Fe 400th 20 21 Anniversary, Inc.; and WHEREAS, the city has contracted with the Santa Fe 400th Anniversary Inc. to provide 22 services on behalf of the city for the Santa Fe 400th anniversary commemoration for the years 23 24 2008 through 2010; and WHEREAS, such services have included the development and implementation of

projects and programs, for the city of Santa Fe's 400th anniversary that are consistent with the importance of the occasion and that show respect for the collective heritage of the community; and

WHEREAS, the planned 400th commemoration events bring visitors to the community increasing gross receipts tax received by the city; and

WHEREAS, because of the difficult economic times, the 400th Anniversary Inc.'s fundraising efforts have been limited and therefore, additional city funds, in the amount of \$20,000, are needed to cover the expenses for a Spanish State visit and a visit from the Mexican President or his designee; and

WHEREAS, the State of New Mexico and the County of Santa Fe are expected to also provide funding for the Spanish State visit and the Mexican Presidential visits in the amount of \$20,000; and

WHEREAS, these two special State visits from the Spanish sister cities and the Mexican President will be of great honor to the City and its residents.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF SANTA FE that funding is approved in the amount of \$20,000 to assist Santa Fe 400th Anniversary, Inc. for the Spanish State visit, the Mexican Presidential visit and closing ceremonies upon the following conditions:

- 1. The funding shall come from the Lodgers' Tax reserves;
- Written confirmation shall be received regarding funding from the State of New
 Mexico and the County of Santa Fe in the amount described above;
- 3. The city's funding shall not be used for any other purpose than the two special visits and the closing ceremonies; and
- 4. Staff is directed to prepare a budget adjustment and amend the contract with Santa Fe 400th Anniversary, Inc. accordingly.
