	DIRECTING STAFF TO SUBMIT A SPONSOR LETTER TO THE NATURAL		
12	RESOURCES CONSERVATION SERVICE, UNITED STATES DEPARTMENT OF		
13	AGRICULTURE, TO REQUEST EMERGENCY WATERSHED PROTECTION		
14	PROGRAM FUNDS TO PROTECT, PRESERVE AND RESTORE ANY DAMAGE OR		
15	POTENTIAL DAMAGE TO THE BUCKMAN DIRECT DIVERSION PROJECT AS A		
16	RESULT OF THE LAS CONCHAS FIRE.		
17			
18	WHEREAS, the Las Conchas Fire began on June 26, 2011, approximately 12 miles		
19	southwest of Los Alamos and as of June 28, 2011 has burned 60,741 acres and is 0% contained;		
20	and		
21	WHEREAS, the Las Conchas Fire is being fueled by mixed conifer and Ponderosa Pin		
22	and the fuel moisture is extremely low; and		
23	WHEREAS, the Las Conchas Fire Update, as of June 28, 2011, is attached hereto as		
24	Exhibit "A"; and		
25	WHEREAS, the Las Conchas Fire is an immediate potential threat to the Buckman		

1	Direct Diverson Project ("BDD") because the fire could have direct impact on watersheds with			
2	tributaries that feed the Rio Grande above the BDD; and			
3	WHEREAS, the Las Conchas Fire could also be a long term threat to the BDD becaus			
4	after the Fire the lands will no longer have sufficient vegetative cover to hold back torrential			
5	monsoon rains which may cause flooding, degradation and soot and debris to impair the			
6	watersheds that feed the Rio Grande above the BDD; and			
7	WHEREAS, if the watersheds with tributaries that feed the Rio Grande are affected by			
8	the Las Conchas Fire, there would be a direct impact on the incoming water quality to the BDD,			
9	including without limitation, impact on treatment requirements and sampling requirements; and			
10	WHEREAS, the Natural Resources Conservation Service ("NRCS"), a division of the			
11	Department of Agriculture, has established the Emergency Watershed Protection ("EWP")			
12	program; and			
13	WHEREAS, EWP is designed to resolve imminent hazards to life and property caused			
14	by fires and other natural disasters and is a funding mechanism for the City to tap into to protect			
15	its land and private land and to protect the citizens of the City from the aftermath of the Las			
16	Conchas Fire; and			
17	WHEREAS, EWP funds may be used to remove debris from stream channels, stabilize			
18	road culverts and bridges, reshape and protect eroded banks, correct damaged drainage facilities			
19	stabilize levees and structures, revegetate damaged areas, and purchase floodplain easements o			
20	lands subject to frequent flooding; and			
21	WHEREAS, NRCS can typically pay up to 75 percent of construction costs of eligible			
22	emergency treatments and the remaining 25 percent must come from local sources and can be in			
23	the form of cash or in-kind services; and			
24	WHEREAS, in order to request EWP funds, the City of Santa Fe must submit a sponsor			
25	letter to the NRCS which will be forwarded to Congress in the order it is received; and			

1	WHEREAS, Congress will make a determination, as to whether the City of Santa Fe		
2	would be approved for funding, depending on the availability of such funding.		
3	NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE		
4	CITY OF SANTA FE staff is directed to draft a sponsor letter signed by the Mayor, along with		
5	this resolution, to the NRCS to request EWP funding in the event there is direct impact or a long		
6	term threat to the BDD resulting from the Las Conchas Fire. Staff is further directed to work		
7	with the New Mexico Office of the NRCS and the State Conservationist's staff in the application		
8	for EWP funds and the implementation of the EWP program.		
9	BE IT FURTHER RESOLVED that staff is directed to forward a copy of the sponsor		
10	letter and this resolution to New Mexico's Congressional Delegation.



Fire Update:

East - Crews are working to protect structures near Bandelier, as well as working to contain the fire along the Frijole Canyon.

West - Crews are building direct lines to prevent fire movement to the west.

Northeast - Crews are working to contain the fire using burnout methods to prevent the fire from spreading north of Pajarito Road and east of Highway 501.

South - North of Cochiti fire progression is being slowed by lighter fuel types. Firefighters are evaluating methods to stop the fire from spreading south.

If you live near the fire or near the Forest, you should always be ready for emergencies including evacuations, the three-step process is easy to remember and implement:

- Ready Take personal responsibility and prepare before the threat of a wildland fire so your home is ready in case of a fire. Create defensible space by clearing brush away from your home. Use fire-resistant landscaping and harden your home with fire-safe construction measures. Assemble emergency supplies and belongings in a safe spot. Plan escapes routes. Make sure all those residing within the home know the plan of action.
- Set Act immediately. Pack your vehicle with your emergency items. Remember your six P's: people, personal computers, pets, pills, papers and pictures. Stay aware of the latest news and information on the fire from local media and your local fire department
- · Go Leave early! Follow your personal action plan. Doing so will not only support your safety, but will allow firefighters to best maneuver resources to combat the fire.

Bandelier National Monument: The Bandelier National Monument will be closed indefinitely.

Los Alamos National Labs: The Los Alamos National Laboratory will be closed due to the fire. All laboratory facilities will be closed for all activities, and nonessential employees are directed to remain off site. Employees that are considered nonessential should not report to work unless specifically directed by their line managers. Employees should check local news sources, the LANL Update Hotline (505) 667-6622 and the LANL web page www.lanl.gov for updates. All radioactive and hazardous material is appropriately accounted for and protected. LANL staff is coordinating the on-site response and supporting the county and federal fire response.

Safety Message

The wildfire and burnout operations will continue to produce heavy smoke. Residents with respiratory problems in the path of smoke may want to consider relocating temporarily until smoke dissipates. Motorists should exercise caution due to reduced visibility.
