10 **A RESOLUTION**

11 **SUPPORTING THE VIP RECEPTION AND GRAND CENTENNIAL BALL TO BE**  
12 **HELD ON JANUARY 6, 2012 AT THE SANTA FE COMMUNITY CONVENTION**  
13 **CENTER, IN HONOR OF THE NEW MEXICO CENTENNIAL; AND AUTHORIZING**  
14 **THE WAIVER OF FEES FOR USE OF THE SANTA FE COMMUNITY CONVENTION**  
15 **CENTER.**

17 **WHEREAS**, on January 6, 1912, New Mexico became the 47<sup>th</sup> state in the Union; and

18 **WHEREAS**, the New Mexico Centennial Foundation, a 501(c)3 nonprofit organization,  
19 was created to support commemorative activities relating to the New Mexico Centennial; and

20 **WHEREAS**, beginning in September 2011 and culminating in December 2012,  
21 communities and organizations throughout New Mexico will honor New Mexico's 100<sup>th</sup>  
22 Anniversary with projects and events that recognize New Mexico's diverse culture; and

23 **WHEREAS**, a VIP Reception and, thereafter, the Grand Centennial Ball are scheduled to  
24 be held on January 6, 2012 at the Santa Fe Community Convention Center; and

25 **WHEREAS**, Resolution No. 2007-109 authorizes certain waivers or reduction of fees for

1 the use of city facilities for an event of a non-profit organization upon the request of a member of  
2 the governing body; and

3 **WHEREAS**, the Governing Body desires to waive the fees for use of the Santa Fe  
4 Community Convention Center for the VIP Reception and Grand Centennial Ball to be held on  
5 January 6, 2012.


6 **NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE**

11 PASSED, APPROVED, and ADOPTED this 27<sup>th</sup> day of September, 2011.


