1. Call to Order

The meeting was called to order by the Chair, Dr. Suzanne Gebhart at 6:05 pm in the City Councilor's Conference Room, City Hall, Santa Fe, New Mexico.

2. Approval of Agenda

3. Approval of Minutes: February 22, 2011

4. Old Business:

A. Membership – Joanne LeFrak

Ms. LeFrak will be approved by the City Council tomorrow night. She will be considered as an outside reviewer until appointed.

B. Needs Assessment Report – Fall, 2010

The Chair asked the Commission members to review the needs assessment report and if there are any substantive changes they should be sent to Dr. Gebhart and/or Dr. Hathaway by email.

Santa Fe County DWI Task Force should be invited to the next needs assessment meeting.

4. New Business

a. Review grant renewal applications - 30 Applications

Process is to do a rapid roll call of the applications. Should the commission feel that there are specific programs that need a more detailed conversation, they will be identified and added time will be given to those programs and identify if these programs need to come in for an interview.

It was confirmed that the amount of money for allocations is \$900,000. Dr. Hathaway distributed the History of Children and Youth Commission funding for the last twenty years.

Mr. Multari also proposed a standard form for the applicants to use in the future which will bring continuity to the review process.

Dr. Hathaway also distributed a mid-year review dated 3/2011.

Dr. Anderson stated that a number of the programs seem to be proposing deficit budgets for the next year; how do we address that issue? The Chair said that she feels it is an important element to take under consideration. Are they going to shut their doors for a lack of money? Dr. Hathaway stated that the program managers have been told that there will not be any more money.

6. Comments from the Chair, Suzanne Gebhart, M.D. and other Commissioners

The Chair stated that there should be a plan in place for transition when Dr. Hathaway retires. The retirement date is end of December, 2011 and staff recommendation is to have a replacement in place by September, 2011 if possible. The Chair and Dr. Hathaway will be in close communications regarding this HR matter and keep the commission members informed.

Ms. Fidel volunteered to look in to car seats. She is working on this project.

7. Report from Staff: Lynn Hathaway a. Monthly Status Report

Grant Balance Sheet: 61% has been expended. The schools have submitted their reimbursement requests. The way they are reporting gets complicated on how they report the numbers in scope of service.

The book is complete and it will be presented to the City Council on April 27, 2011. The Program Administrators, Grantees and friends of the Commission should see the book and they should be invited to the City Council meeting. Each program will get 10 copies, we have 1,000 copies. Don Usner the Photographer will be there. Dr. Hathaway said if the commission members have places that they would like books to be taken to or have Dr. Hathaway make a presentation on the commission, she is happy to do this.
