#### F. NEW BUSINESS

1. CASE #AR-08-11. APPROVAL OF A RECONNAISSANCE REPORT FOR AN ARCHAEOLOGICAL INVENTORY AND TESTING OF 0.47 ACRES AT 1005 EAST ALAMEDA, SANTA FE, NEW MEXICO. (HISTORIC DOWNTOWN). REQUESTED BY RON WINTERS. (DAVID RASCH)

Mr. Winters said the title doesn't reflect that this Report is only for Lots H and L, although he does say it in the Report, and he will make that change.

Mr. Winters said the Appendix with the profiles is missing from the Report, noting he just failed to print that portion, and it will be attached to the Report.

Mr. Winters said the property is unique in that it drops off severely in Lot H, noting Lot H is heavily wooded, as you can see in Figure 4. He said this is the reason he did the hand units. He said it would be impossible to get a machine into the area and this is the reason there is no backhoe trenching. He said there is a 15 degree slope where it breaks at the fence line on the plat between Lots L and H.

Mr. Funkhouser said he provided his comments to Mr. Winters prior to the meeting.

Mr. Eck he said another survey was done in this immediate area, within 50 meters of where Mr. Winters was working, and it hasn't gotten to ARMS, although he doesn't know the reason, noting the survey was done by Abbott.

Mr. Winters said the latest surveys he has were the ones he did in 2009, although he is sure something has been done. He said he will check on this.

Mr. Eck offered the following correction: page 24, paragraph 3, line 1, correct as follows: "... 2 feet 2-foot wide..."

Mr. Eck said there needs to be a citation on page 28, for Figure 8.

Mr. Ivey said there needs to be another space between paragraphs 2 and 3 on page 4.

**MOTION:** Jake Ivey moved, seconded by Gary Funkhouser, with respect to Case AR-08-11, to approve the Reconnaissance Report for an Archaeological Inventory and Testing of 0.47 Acres at 1005 East Alameda, Lots H and L, Santa Fe, New Mexico, in the Historic Downtown, requested by Ron Winters, with the aforementioned editorial changes and including the addition of the Appendix with the profiles and the referenced sections at the back of trenches.
