11 SUPPORTING THE NEW MEXICO LITTER CONTROL AND  
12 BEAUTIFICATION ACT OF 1985 WHICH PROVIDES PUBLIC FUNDS IN  
13 THE FORM OF GRANTS FOR THE PURPOSE OF ENHANCING LOCAL  
14 LITTER CONTROL AND BEAUTIFICATION PROGRAMS.

16 WHEREAS, the city of Santa Fe recognizes the existence of a litter problem within the  
17 boundaries of Santa Fe; and

18 WHEREAS, the New Mexico Litter Control & Beautification Act of 1985 (the "ACT")  
19 provides, through the State Tourism Department, Litter Control and Beautification Section, for  
20 the allocation of public funds in the form of grants for the purpose of enhancing local litter  
21 control and beautification programs; and

22 WHEREAS, the city of Santa Fe has reviewed and considered the regulations, the  
23 agreement covering administration and use of said funds.


24 NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE  
25 CITY OF SANTA FE that the city of Santa Fe:

1 Section 1. Endorses and supports such a program and delegates the administration of  
2 such program to Keep Santa Fe Beautiful Inc., as indicated in Exhibit "A" attached hereto and  
3 incorporated herein by reference.

4 Section 2. Authorizes Keep Santa Fe Beautiful Inc. to plan, budget and apply for a grant  
5 under the ACT which if approved, will be used to fund said programs.


6 Section 3. Requests the State Tourism Department, Litter Control Beautification Section  
7 to consider and approve said application and program. Said program is in accordance with the  
8 Act and related regulations governing the use and expenditure of said funds.
