• Minutes of the initial meeting on **September 29th 2011**: RC moves to approve draft minutes with tracked changes. DG seconds. Committee approves by consent with no objections.

D. Unfinished Business

- SM maps an overview of law; policy; franchises; and public initiatives
- SM sketches a conceptual timeline through preliminary and final reports
- SM requests direction to revise committee reporting dates. SE moves to direct SM to advise Council of revised reporting dates @ 6 months from current date for preliminary report & 12 months for final report. RC seconds. Committee approves by consent with no objections.
- SM reviews committee's duties to present preliminary & final reports; to develop a master plan; and to advise the Governing Body on any telecommunications matter or policy. RC asks what the Governing Body desires the committee to accomplish, and which Councilor sponsored the authorizing ordinance/resolution. SM reports that he has not discussed with the Mayor or any Councilor and is responding only to what is documented in the legislation and in existing City policy, informed by the advice of staff. Councilor Bushee is the sponsor. RC directs SM to investigate and report back. GC also requests voting results.

E. New Business

- · Baseline study
 - SM asks Mr. Sills to describe the work SFRTC has done to document existing conditions and to analyse needs. Documentation includes an assessment of existing City conduit; a list of potential subscribers to SFRTC's Phase 1 Fiber Ring study; and their initial and projected speed requirements. No additional baseline documentation or needs analysis is identified, nor is being pursued by SFRTC. Mr. Sills offers cooperation with committee's inquiry.

- SM projects an interactive New Mexico Broadband Map of the city showing overlays of DSL; cable; fiber; and fixed wireless. National rankings of the city with respect to speed and coverage are displayed and discussed. GC explains how the data was gathered, and the shortcomings of the fiber overlay in particular. Ms. Hill describes Cyber Mesa's new fixed wireless and GSHDSL capabilities.
