100 which directed staff to propose solutions to the continued practice of improper disposal of

2	WHEREAS, the emphasis of the "Don't Dump Santa Fe" program will be to educate our
3	community regarding the proper disposal of used motor oil and antifreeze; and
4	WHEREAS, the "Don't Dump Santa Fe" program will serve our community by
5	protecting our citizens from contaminates, vectors, and disease caused by improper disposal of oil
6	and antifreeze and will ensure a healthier environment.
7	NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE
8	CITY OF SANTA FE that staff is authorized to submit an Illegal Dumping Grant Application to
9	the State of New Mexico Environment Department in the amount of twenty thousand dollars
10	(\$20,000) for the "Don't Dump Santa Fe" program.
