

SUPPORTING THE APPLICATION AND RESPONSE TO THE REQUEST FOR PROPOSALS ISSUED BY THE NORTH CENTRAL NEW MEXICO ECONOMIC DEVELOPMENT DISTRICT, NON-METRO NEW MEXICO AREA AGENCY ON AGING FOR CONTINUATION OF SERVICES FOR SENIOR CITIZENS OF THE CITY AND COUNTY OF SANTA FE.

WHEREAS, the Older Americans Act of 1965, as amended, was enacted by Congress to ensure provision of social services for America's elderly population; and

WHEREAS, the Division of Senior Services of the City of Santa Fe administers social services such as congregate meals, home delivered meals, house keeping, adult day care, respite, transportation and health promotion activities for senior citizens living throughout our community; and

WHEREAS, every four years, the North Central New Mexico Economic Development District,
Non-Metro New Mexico Area Agency on Aging ("Area Agency on Aging") issues a Request for
Proposals ("RFP") for prospective vendors to provide services for senior citizens; and

WHEREAS, currently the Division of Senior Services has a vendor agreement with the Area Agency on Aging to provide services for senior citizens; and

1	WHEREAS, the current vendor agreement expires on June 30, 2008.
2	NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY
3	OF SANTA FE that the Governing Body supports the application and response to the RFP issued by the
4	Area Agency on Aging for the continuation of services to the senior citizens of our community; and if
5	awarded a vendor agreement, is authorized to sign and enter into a contract with Area Agency on Aging
6	for the four year funding cycle, July 1, 2008 through June 30, 2012.
