#### A COMBINED RESOLUTION

#### AUTHORIZING CITY OF SANTA FE, COUNTY OF SANTA FE AND SFSWMA REPRESENTATIVES TO SIGN THE RURAL INFRASTRUCTURE LOAN AGREEMENT TO BE FINANCED BY THE NEW MEXICO ENVIRONMENT DEPARTMENT – CONSTRUCTION PROGRAMS BUREAU FOR THE CELL 4B SOLID WASTE PROJECT, AND AUTHORIZING THE SFSWMA EXECUTIVE DIRECTOR TO ACT AS THE LOAN RESPRESENTATIVE AND SIGNATORY AUTHORITY FOR REIMBURSEMENT REQUESTS

WHEREAS, the Santa Fe Solid Waste Management Agency ("SFSWMA") is governed by a Joint Powers Agreement between the City of Santa Fe ("City") and the County of Santa Fe ("County") pursuant to the Joint Powers Agreements Act, NMSA 1978, §§ 11-1-1 to 11-1-7; and

WHEREAS, SFSWMA is a qualified local authority under the New Mexico Rural Infrastructure Act, NMSA 1978, §§ 75-1-1 to 75-1-6 ("Act"), and the governing body of SFSWMA is authorized to borrow funds for financing of solid waste public projects for the benefit of the City and County with the approval of the Santa Fe City Council and Santa Fe Board of County Commissioners; and

WHEREAS, the New Mexico Environment Department - Construction Programs Bureau ("Department") requires a resolution designating authorized representatives to sign the rural infrastructure loan agreement for financing the Caja del Rio Landfill - Cell 4B ("Project"), an authorized loan representative to act as the single point of contact with the Department during the duration of the Project, and an authorized representative to sign reimbursement requests and other documents for the Project for submittal to the Department; and

WHEREAS, this resolution will be part of the rural infrastructure revolving loan fund application ("Application") for the Project that has been completed and submitted to the SFSWMA Joint Powers Board, the Santa Fe City Council, and the Santa Fe Board of County Commissioners.

#### NOW THEREFORE, BE IT RESOLVED BY THE SANTA FE SOLID WASTE

#### MANAGEMENT AGENCY JOINT POWERS BOARD, THE SANTA FE CITY

#### COUNCIL, AND THE SANTA FE BOARD OF COUNTY COMMISSIONERS:

Section 1. Mayor David Coss of the City of Santa Fe; Jack Sullivan, Chair of the Santa Fe Board of County Commissioners; and Ronald S. Trujillo, SFSWMA Chairperson are hereby authorized to sign the loan agreement for the Project; and

Section 2. The SFSWMA Executive Director is hereby authorized to submit any documents pertaining to the Project to the Department and act as a single point of contact; and

Section 3. The SFSWMA Executive Director is hereby authorized to sign reimbursement requests and other documents requiring a signatory for submittal to the Department.

Section 4. All acts and resolutions in conflict with this resolution are hereby rescinded, annulled and repealed.

Section 5. This resolution shall take effect immediately upon its adoption.
