10 **A RESOLUTION**

11 **AMENDING THE DESIGNATED FUNDING FOR INTERIM BRIDGE REHABILITATION,**  
12 **APPROVED BY THE GOVERNING BODY ON NOVEMBER 30, 2011, SO THAT ALL**  
13 **SUCH DESIGNATED FUNDING BE USED, IN CONJUNCTION WITH OTHER LOCAL,**  
14 **STATE AND FEDERAL FUNDING MECHANISMS, TO REPLACE THE DEFOURI**  
15 **STREET BRIDGE.**

16  
17 **WHEREAS**, on November 30, 2011, the Governing Body adopted Resolution No. 2011-67  
18 which designated a CIP project list to be funded by a gross receipts tax bond issues; and

19 **WHEREAS**, pursuant to the CIP project list, \$500,000 is currently designated for Guadalupe  
20 Street and Defouri Street bridge rehabilitation; and

21 **WHEREAS**, the Public Works Department continues to monitor bridge ratings and  
22 conditions in Santa Fe; and

23 **WHEREAS**, as of February 2012, the Defouri Street bridge was rated as having the lowest  
24 bridge sufficiency rating of city owned bridges in the city of Santa Fe; and

25 **WHEREAS**, the Defouri Street bridge is also deficient in pedestrian access and is one of the

1 narrowest of all downtown bridges; and

2 **WHEREAS**, the Defouri Street bridge has been qualified for complete replacement.

3 **NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE**  
4 **CITY OF SANTA FE** that the November 30, 2011 CIP project list is amended to change the  
5 following line item:

6 **Under Category 1, Infrastructure Improvements**

7 Bridge Rehabilitation \$500,000 [~~Guadalupe St. and~~] Defouri St.

8 [~~interim bridge rehabilitation~~]

9 Bridge replacement


10 **BE IT FURTHER RESOLVED** that in conjunction with the \$500,000 CIP funding for the

12 Mexico Department of Transportation, the Federal Highway Administration, and any other funding

14 PASSED, APPROVED, and ADOPTED this 11<sup>th</sup> day of April, 2012.


