CHILDREN AND YOUTH COMMISSION MEETING

Tuesday, February 26, 2013 Councilors' Conference Room City Hall, 1st floor 200 Lincoln Avenue 6:00-8:00 p.m.

1. Call to Order and Roll Call

The meeting was called to order by the Chair, Sue Anne Hermann, at 6:00 pm in the City Councilor's Conference Room.

2. Approval of Agenda

Ms. Fidel moved to approve the agenda as presented, second by Mr. Multari, motion carried by unanimous voice vote.

3. Approval of Minutes: February 5, 2013

Mr. Bustamante moved to approve the minutes of February 5, 2013 as amended, second by Ms. Fidel, motion carried by unanimous voice vote.

4. New Business

a. Boys and Girls Club Update

Ms. Gallegos de Hagman referred to the recent article in the Newspaper which provided an update on the scenario of the Boys and Girls Club. Mr. Roman Abeyta, Professional Director for the Club relayed the same information and said that they are using CYFD money and trying to be creative in the use of these funds as best they

can. They have some systems in place to be more alert as to what is happening. Mr. Chris Sanchez and Ms. Gallegos de Hagman attended this meeting with the Boys and Girls Club Board members and Mr. Abeyta. A strategic plan template was provided to them as a tool. Mr. Abeyta conveyed to Ms. Gallegos de Hagman and Mr. Sanchez that they would be meeting with SFPS regarding the transportation system in hopes of receiving some aid from them. A follow up report will be provided to the Children and Youth Commission. Presently they have access to two buses that pick up at 17 schools. It was noted by Mr. Abeyta that at some schools they have over 20 students in one school. Mr. Sanchez asked them to do a strategic plan and they discussed the credit recovery program. Mr. Abeyta said that he would look in to this proposal. Credit recovery is a program for kids who have been out of school for at least 2 years and this would allow them to go back to computerized school to earn their credits. (Exhibit A – Report on expenses for fuel, drivers and insurance for transportation). This report indicates close to \$45,000. This report was created as a discussion tool when meeting with SFPS. Mr. Multari asked what are the differences in services when comparing what is received at the Boys and Girls Club vs. the after school programs. A couple of the programs are the computer and drama program and the food component. It was noted by Mr. Abeyta that the only way the program at the Boys and Girls Club will survive is with the CYFD money and the rates charged to the families for service.

Mr. Sanchez said that he will do a study on the duplication of any services for the 35 programs that the city funds and provide this information to the commission.

It was noted that the \$45,000 award that the city provided the Boys and Girls Club doesn't even cover their transportation costs. It was reiterated that the commission wants to award the money wisely. Mr. Bustamante noted that under the direction of Mr. Abeyta at the Boys and Girls Club, it has become more visible that he has provided a stronger outlook to those funding agencies and they recognize his professional endeavors for the Boys and Girls Club. Outside funding agencies are looking at them closer and giving them more consideration.

The commissioners would like to see the Boys and Girls Club strategic plan before any funding decisions are made at the time of renewal.

b. Site Visits Update: Zona del Sol and Warehouse 21

Ms. Rodriguez reported that a site visit was made to Zona del Sol based on their inconsistent reporting in the past which is important. Zona is its own 501C3 but the city owns the property. It was noted that this program presents itself as a "start up program"; it doesn't really show that it has been in existence for 13 years. They have a lot of great ideas but they could not produce a strategic plan or any type of goals and objectives or project plan to show what they have done or where they are going. They are only open 12 hours a week, they close by 5 pm and they are not open on the weekends. Ms. Rodriguez said that they did have a successful summer program which included Earth Care, FACT and Cooking with Kids which served 40 kids.

Their hours of operation are 8:30 am to 3:30 pm which does not allow a good window of time for children to participate. It is very evident that the Chairman of the Board is very invested in this program and is so supportive of the staff and the needs of Zona both in care of the facility and in a monetary manner. It was recommended that staff find out what is the total amount of people served throughout the year. Q: How does a program like this show us how the money is spent? It was stated that the funding received from the City of Santa Fe is used for the Project Coordinators salary. Earth Care and FACT are also housed out of this building. It was stated that when the review process takes place it will be important to define direct services and that the use of city funding is to be used for such. Mr. Sanchez said that this facility has such a high potential to service the growing youth population on the south side. Another suggestion was to look at the organizations that are being funded by Children and Youth and note if they are having space concerns, Zona might be a good resource for them.

Site visit to Warehouse 21: Mr. Sanchez said that there was only one person at Warehouse 21 for this site visit. Ms. Lefrak said that there is an awesome amount of kids who are involved in art but they don't go to Warehouse 21. Although the budget information shared with Ms. Rodriguez and Mr. Sanchez looked healthy, almost half of their expenditures are rent payment. A written report will be finalized and sent on to the commissioners by e-mail. It was also noted that they are closed, Sunday, Monday and Tuesday. (They share all of their event schedules with the city.) It is important to separate out the events and provide a place for the kids to go in the evening.

Ms. Rodriguez asked the commissioners to look at the format of the new report which encompasses quite a bit of information and provide feedback.

The Chair said that in both scenarios for Zona and Warehouse 21 the location plays a big part in their lack of success.

c. Juvenile Justice Steering Committee Update
Richard DeMella – Juvenile Justice Planner, City of Santa Fe, introduced himself to
the commission and said that for years he has wanted to work collaboratively with the
Children and Youth Commission. Presently they are doing tutoring at Cesar Chavez
for children K-6. The Principal is the one who identifies the kids for this particular
program. There is a day reporting program which is at YDC (Detention Center on
Airport Road). Juvenile Justice works closely with the schools and the courts.
Juvenile Justice works diligently on alternatives to detention. They also have a
gender program to help the females as their treatment and concerns are different. If
you can help these kids now at this age it can keep them from ending up in the adult
criminal system. Mr. DeMella and Mr. Sanchez are working together to identify
programs that they can work on for these kids and create wrap around services. Santa
Fe County has a facility they have offered and the schools have the kids if we can
create the wrap around services. Mr. Sanchez would like to join program services in
a non-secure facility and provide them with the services that they need after they go

through an evaluation and he feels you can get these kids back on track. Day Reporting right now handles 15 to 18 kids but it has been expressed that there could be up to 250 kids ready for a program like this. Intensive Community Monitoring (ICM) – this is a program that works with the kids individually. Family Youth Resource Advocate (FYRA) works with family's and kids in groups. Day Reporting is for kids who have gone before the courts and they don't want to incarcerate them, so they go to class in this program. This is for Santa Fe, Rio Arriba and Los Alamos Counties. Mr. DeMella stressed that education is not emphasized enough in this community. Mr. Sanchez reiterated that if we could identify the same kids then we can collaborate and provide better services and maximize in our funding. Mr. DeMella reiterated that this is not going to cost a dime to Children and Youth; it is going to be a collaboration and commitment to get the kids into the program and provide the services. Thank you to Mr. DeMella and Mr. Sanchez for this information.

d. Request for Renewal Update: (hand out and discussion of schedule)
The RFP has been released. A schedule for Children and Youth Funding Process for 2013-2014 was distributed. (Exhibit B) It was the preference of the commission that the dates remain the same, April 9-10 and 11th. April 9-10-11 would be at the Solace location. April 9th and 10th full days and on the 11th start at 1:00 pm.

5. Old Business

a. Status of filling vacancy on the Commission

The Chair said that she was pleased that Ms. Reichman is happy to serve on the Children and Youth Commission if appointed by the Mayor and City Council.

Mr. Bustamante moved to recommend Jill Reichman as commissioner for the Children and Youth Commission and send this recommendation on to the Mayor, second by Ms. Lefrak, motion carried by unanimous voice vote.

6. Comments from the Chair and Commissioners

The Chair reported on her attendance at the Santa Fe Regional Juvenile Justice Committee meeting.

Ms. Fidel asked how the after school program differs and why are they different. Ms. Rodriguez will provide Ms. Fidel with the minutes from a previous meeting that defined what the after school programs provide. Mr. Sanchez will do site visits to Agua Fria, Salazar, Adelante and Piñon After School programs and report back at next meeting.
