11	AUTHORIZING THE CITY OF SANTA FE TO ENTER INTO AN ANNUAL AGREEMENT
12	WITH THE RODEO de SANTA FE AND THE NEW MEXICO GAY RODEO
13	ASSOCIATION ("NMGRA") ZIA REGIONAL RODEO; SUBJECT TO AVAILABLE
14	APPROPRIATIONS MADE BY THE GOVERNING BODY.

16	WHEREAS, the Rodeo de Santa Fe remains one of the top 60 PRCA Rodeos in the nation
17	that draws local residents and visitors from around the Country to enjoy the rodeo, the carnival
18	midway, concessions and vendors which contributes to Santa Fe's economy and increases GRT; and
19	WHEREAS, NMGRA hosts the annual Zia Regional Rodeo and Rodeo School which is held
20	at the Rodeo de Santa Fe Arena; and
21	WHEREAS, attendance at the Zia Regional Rodeo has been at an all time high and has
22	generated many rodeo fans from around the world and brings together people from a wide range of
23	locations and from all walks of life; and
24	WHEREAS, both rodeo organizations pay for City services such as environmental services
25	and paramedic services; and

1	WHEREAS, the Governing Body desires to be a proud annual sponsor of the annual Rodeo
2	de Santa Fe and the annual Zia Regional Rodeo.
3	NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE
4	CITY OF SANTA FE that subject to available appropriations, the Governing Body hereby
5	authorizes the City of Santa Fe to enter into:
6	1. An annual agreement for the Rodeo de Santa Fe in an amount not to exceed \$10,000
7	in cash or in-kind services or a combination of both cash and in-kind services in
8	return for equal value provided to the City by the Rodeo de Santa Fe; and
9	2. An annual agreement for the Zia Regional Rodeo in an amount not to exceed \$10,00
10	in cash or in-kind services or a combination of both cash and in-kind services in
11	return for equal value provided to the City by the Zia Regional Rodeo.
