10 **A RESOLUTION**

11 **RELATING TO THE PRACTICE OF HUMAN TRAFFICKING; ENDORSING,**  
12 **SUPPORTING AND JOINING THE EFFORTS OF THE NEW MEXICO ATTORNEY**  
13 **GENERAL'S OFFICE AND THE LIFE LINK IN ESTABLISHING A HOTLINE TO**  
14 **FACILITATE SUPPORT FOR VICTIMS OF HUMAN TRAFFICKING; AND**  
15 **AUTHORIZING THE DESIGNATION OF FUNDING FOR CREATION AND PLACEMENT**  
16 **OF SIGNS AND ADVERTISING WITHIN THE CITY OF SANTA FE TO INFORM THE**  
17 **PUBLIC OF THE HOTLINE.**

19 **WHEREAS**, Santa Fe, New Mexico is a free city; and

20 **WHEREAS**, the New Mexico Attorney General's Office and The Life Link recognize that  
21 human trafficking in labor and sexual services is a criminal act; and

22 **WHEREAS**, the New Mexico Attorney General's Office and The Life Link have joined  
23 together in establishing a 1-505-GET-FREE hotline to facilitate support for victims of human  
24 trafficking; and

25 **WHEREAS**, the Governing Body desires to join the efforts of the New Mexico Attorney

1 General's Office and The Life Link to place signs in certain places within the city of Santa Fe to  
2 inform the public of the hotline; and

3 **WHEREAS**, the proposed design of the sign is attached to this resolution as Exhibit "A".

4 **NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE**  
5 **CITY OF SANTA FE** that the Governing Body:

6 1. Endorses, supports and joins the efforts of the New Mexico Attorney General's Office  
7 and The Life Link in establishing a hotline to facilitate support for victims of human  
8 trafficking; and


9 2. Authorizes the designation of funding in the amount of up to \$5,000 for the creation and  
10 placement of signs and advertising in the City to inform the public of the 1-505-GET-  
11 FREE hotline; and

12 3. Directs staff to facilitate the location and placement of the signs in accordance with City  
13 ordinances, policies and procedures.

14 **BE IT FURTHER RESOLVED** that the signs shall be designed in accordance with  
15 best practice signage and each sign shall include the City's logo with a notation that states




