**A RESOLUTION**

**ENDORING THE ELIMINATION OF FARES FOR CERTAIN SPECIAL EVENT  
TRANSIT SERVICES PROVIDED BY THE CITY OF SANTA FE AND FUNDED BY THE  
NORTH CENTRAL REGIONAL TRANSIT DISTRICT (“NCRTD”), IN ACCORDANCE  
WITH THE NCRTD’S FARE FREE SERVICE POLICY.**

**WHEREAS**, the NCRTD collects 1/8% gross receipts regional transit tax in Santa Fe County to fund regional transit operations; and

**WHEREAS**, the NCRTD provided a portion of the revenues from the regional transit tax to the City of Santa Fe to deliver transit services that are regional in nature; and

**WHEREAS**, the regularly scheduled regional transit services provided by the City of Santa Fe on behalf of the NCRTD allow passengers free transfers to Santa Fe Trails from both the Rail Runner and New Mexico Park and Ride bus operations; and

**WHEREAS**, the Santa Fe Pick-Up operates as a regional transit service providing fare-free downtown circulator service; and

**WHEREAS**, some special event transit service operated by the City of Santa Fe, specifically

1 for the Folk Art Market, already operates as a fare free service; and

2 **WHEREAS**, the NCRTD operates as a fare-free system; and

3 **WHEREAS**, the City of Santa Fe intends to honor the NCRTD's fare free policy for services  
4 that it provides, on behalf of the NCRTD in the City of Santa Fe, and for which operating expenses  
5 are reimbursed by the NCRTD.


6 **NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE**  
7 **CITY OF SANTA FE** that in accordance with the NCRTD's fare-free policy, Santa Fe Trails offer  
8 fare free service on the Saturday and Sunday of Spanish Market and Indian Market weekends, the  
9 evening of the burning of Zozobra, and the Christmas Eve farolito walk on Canyon Road.
