Ms. Van Peski moved to approve the Minutes of the April 11, 2013 meeting as submitted. Ms. Pope seconded the motion. The motion passed unanimously by voice vote.

5. DISCUSSION AND ACTION ITEMS

a. Public Works Department – Request to use Impact Fees (Desirae Lujan)
 Airport Road – Landscaping of the Safety Medians: Request \$80,000
 from the Road Impact Fee Account

[Copies of the Memo {Exhibit "5A"} from Desirae Lujan to the Capital Improvement Advisory Committee dated May 7, 2013 were distributed in the Committee Members' packets.]

Mr. Liming introduced Eric Martinez and Desirae Lujan of the Public Works Department.

The Public Works Department is requesting approval to allocate Impact Fee funds in the amount of \$80,000 for construction of the Airport Road Landscaping Project.

The City of Santa Fe Public Works Department issued a request for bids on March 6, 2013 for project construction. The reference project includes installation of an irrigation system along Airport Road from Country Club to Lopez Lane, also completes landscaping of the medians which were built as part of recent safety improvements and thus fully completes the project. Currently, funds in the amount of \$420,000 are available for project construction. Funds in the amount of \$500,000 are required for construction, New Mexico Gross Receipts Tax and contingencies. Therefore, additional funds in the amount of \$80,000 are required to award a construction contract. It is recommended that \$80,000 in impact fees are utilized to fully fund project construction.

The project is identified in the Impact Fees Capital Improvement Plan for Planned Road Improvements (2007-2012, Table 22, page 23).

Ms. Lujan presented the request noting that the bids for the project came in slightly lower than estimated.

Chair Walker asked if these were local bidders.

Ms. Lujan said there were five bidders but none of them were from Santa Fe.

Chair Walker questioned whether or not landscaping fits under the State statute. One of the requirements of the State statute is that capital has to last 10 years and how do you guarantee that landscaping will last 10 years.

Ms. Pope said anytime you build a new building, you have to do some landscaping.

Ms. Lujan explained that the majority of this project is for the irrigation system.

Mr. Chapman said in this case, irrigation would be infrastructure.

Ms. Van Peski moved to approve the request to use Impact Fees in the amount of \$80,000 for the Airport Road project (for the irrigation system). Mr. Lucero seconded the motion. The motion passed unanimously by voice vote.

ITEM AND ISSUE:

REQUEST FOR APPROVAL TO ALLOCATE IMPACT FEE FUNDS IN THE AMOUNT OF \$80,000 FOR CONSTRUCTION OF CIP #872A – AIRPORT ROAD LANDSCAPING PROJECT.

BACKGROUND & SUMMARY:

The City of Santa Fe Public Works Department issued a request for bids on March 6, 2013 for project construction. The referenced project includes installation of an irrigation system along Airport Road from Country Club Road to Lopez Lane, also completes landscaping of the medians which were built as part of recent safety improvements and thus fully completes the project. Currently, funds in the amount of \$420,000 are available for project construction. Funds in the amount of \$500,000 are required for construction, New Mexico Gross Receipts Tax and contingencies. Therefore, additional funds in the amount of \$80,000 are required to award a construction contract. It is recommended that \$80,000 in impact fees are utilized to fully fund project construction. The project is identified in the Impact Fees Capital Improvement Plan for Planned Road Improvements (2007-2012, Table 22, Page 23).

As summarized in Table 22, planned road, intersection and traffic signal improvements identified and eligible to receive impact fee funding over the next six years total \$169.7 million. Because the consumption-based methodology is conservative for the reasons described earlier, it is not surprising that planned capacity-expanding improvements to the major road system are likely to cost considerably more than what is indicated by the previous table.
