11	DIRECTING STAFF TO BEGIN THE PROCESS FOR DEDICATING THE CITY-OWNED
12	LAND AROUND THE WATER STREET PARKING LOT AS A CITY PARK AND NAMING
13	THE NEW PARK "CERLETTI PARK".
14	
15	WHEREAS, the area around the Water Street Parking Lot includes Fountain Head Rock, the
16	Stone Chess Table, Turtle Rock, and Tomas Lipps' Stone Monument; and
17	WHEREAS, the Governing Body desires that such area be dedicated as a City-owned park
18	and named after the late Michael Cerletti ("Cerletti"); and
19	WHEREAS, Cerletti worked in the hospitality industry and was the former secretary of the
20	New Mexico Tourism Department under two governors; and
21	WHEREAS, Cerletti made substantial contributions to the city and county of Santa Fe and
22	northern New Mexico by his dedication to the state tourism industry and was named State Tourism
23	Director of the Year in 2010 by the National Council of State Tourism Directors; and
24	WHEREAS, the neighboring businesses around the Water Street parking lot have requested
25	that the City designate the area as a City park and name the park "Cerletti Park" in honor of Cerletti

1	who loved the block near the Hotel St. Francis on Don Gaspar and who had a keen interest in
2	beautification of and bringing tourism to this block.
3	NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE
4	CITY OF SANTA FE that the Governing Body authorizes and directs staff to:
5	(1) Begin the process, in accordance with City ordinances and policies, for dedicating the
6	City-owned land around the Water Street parking lot as a City park and naming the new
7	park "Cerletti Park"; and
8	(2) For the new park, follow the current City permitting processes for activities to take place
9	in the Park which shall be limited to activities allowed under existing City Ordinances
10	and state laws.
