MONDAY, JULY 29, 2013

1. CALL TO ORDER

A regular meeting of the Public Works/CIP & Land Use Committee was called to order on the above date by Chair Rebecca Wurzbarger at approximately 4:45 p.m. in the City Council Chambers, City Hall, 200 Lincoln Avenue, Santa Fé, New Mexico.

2. ROLL CALL

Roll Call indicated the presence of a quorum as follows:

3. APPROVAL OF AGENDA

Councilor Trujillo moved to approve the agenda as presented. Councilor Rivera seconded the motion and it passed by unanimous voice vote.

4. APPROVAL OF CONSENT AGENDA

Councilor Ives asked to pull #10 for discussion.

Councilor Calvert asked to pull #11 for discussion.

Councilor Calvert moved to approve the consent agenda as amended. Councilor Trujillo seconded the motion and it passed by unanimous voice vote.

5. APPROVAL OF MINUTES FROM JULY 29, 2013 PUBLIC WORKS COMMITTEE MEETING

Councilor Calvert moved to approve the minutes of July 29, 2013 as presented. Councilor Trujillo seconded the motion and it passed by unanimous voice vote.

INFORMATIONAL AGENDA

6. UPDATE TO CONTRACTS RELATED TO CIP (ROBERT RODARTE/MARCOS TAPIA)

Mr. Tapia said this listing was what Mr. Rodarte put together. Some of the contracts were CIP and some were not. Those shown as pending were items that were being prepared that would get either additional requests from vendors or they were putting them together for Finance and then to Council.

Chair Wurzbarger explained the Committee wanted to know where the contracts were with respect to local contractors or not local. This was their first opportunity to weigh in on that.

Mr. Tapia said he didn't know from this list.

Chair Wurzbarger reasoned that Mr. Tapia didn't know when the pending ones would go to the Finance Committee. Mr. Tapia agreed.

Chair Wurzbarger said this was a totally different format but the key variable was local or non-local vendor.

Councilor Calvert wondered what the source of funding was on these.

Mr. Tapia said this listing was incomplete. He agreed to amend the report to provide an estimate of the Finance Committee date, secondly a funding source of each contract, and thirdly which vendors were within Santa Fé County.

Chair Wurzbarger said they would expect that at their next meeting.

7. UPDATE ON BOND CAPACITY (MARCOS TAPIA)

Mr. Tapia clarified that the GO Bonds capacity was 4% on the City's assets valuation. The Department

of Finance Exhibit A described the tabulations. That exhibit was given by the Department of Finance and \$310 billion was the value given.

On #2 of memo he said the current limit was \$149 million and the City had \$126 million outstanding last time. \$12 million was just issued and now the total outstanding was up to \$153 million and the amount the City could borrow now was \$115 million.

Councilor Rivera said there was defensive posturing in response from Moody's on the capacity. He asked if it was feasible to get a report from Moody's and learn from that. He asked if it would be possible to learn what Moody's saw that the City might not have seen.

Mr. Tapia said they did a report on the 2008 water bonds and he agreed to provide the report to Mr. Pino to distribute to the Committee.

Chair Wurzbarger said she needed a copy before Wednesday. Mr. Tapia agreed to provide it to her.

Councilor Rivera asked if he could email it. Mr. Tapia agreed.

Councilor Ives asked about the bonding capacity for CIP bonds.

Mr. Tapia said he provided the City Manager alternatives for reducing the City's debt service with several scenarios and could provide that for the Committee.

Councilor Ives thanked him and asked that it be put on the next agenda.

Chair Wurzbarger agreed. She said she would like to have a big picture that takes any money the City was borrowing from anyone and outline the capacity related to each source. She presumed the \$115 million was only for GO Bonds. Related to that, she continued to be questioned on the issue of the relationship between our "unfunded liabilities" and the debt. She asked what unfunded liabilities the City had, if any. She would be happy to meet with Mr. Tapia on her own if no one else was interested.

Councilor Ives and Councilor Rivera were also interested.

Mr. Tapia thought it was a great idea to talk about that unfunded liability issue that was put on the internet by Moody's.

Chair Wurzbarger noted that people in Santa Fé were afraid so we need to know. PERA was the only source so she questioned what it really meant.

Mr. Tapia offered to tell the Committee about it and the City's response to it.

Councilor Calvert said they knew they had GO bond obligations and what was available from property tax for that. There were also CIP bonds and revenue bonds for the Railyard. The City also had bonds and loans from the state (NMFA). So the Committee needed a comprehensive picture of what the city owes and what resources the City had to pay for them. That comprehensive list would be informative.

Chair Wurzbarger asked in 1A what the criteria of 4% meant. That the City could go out next week and spend \$115 million was something she wanted to understand.

Councilor Ives said he had heard that the City had funded all of its obligations with PERA. If the PERA portfolio has dropped and didn't cover the liabilities he wondered if there was any capacity of PERA to come and say they needed this much more.

Chair Wurzbarger agreed and asked what the consequences were if PERA couldn't do it. She asked if the City expected its employees to just accept it or if there were other obligations the City had to the employees.

Mr. Tapia said his staff was already on it.

Chair Wurzbarger asked for 30 minutes next time and any resources Mr. Tapia could provide ahead of time would help.

Mr. Vigil said he was asking permission for the City to sell this small parcel currently being used by Seret and Sons. The City purchased it as part of a rehabilitation project and was an area for right-of-way use but was not used as such.

Councilor Ives noted they had 4-5 of these small pieces in the last two months and he was trying to figure out whether they were all coincidently coming and what the City wanted to do with them.

Mr. Vigil replied that they come sporadically but usually in the spring. Sometimes there was a change of heart by applicant so the City couldn't anticipate when they would happen.

Councilor Ives wasn't sure if the City was doing a periodic inventory on them or whether the City was asking them if they could use that property. He was at a lecture by Jeff Speck who talked about walkability in Santa Fé and connectivity between the Railyard and downtown. The "view shed" included whether the walk was interesting. Most of this lot was used for storage of old building materials and was not the most attractive use. He asked if the City was promoting more of it if they approved this request and lessening the City's ability to control the view shed. He asked if it came with any limitations. It was not really an attractive use.

Mr. Vigil agreed there were conditions including a dedicated ROW for utilities so no permanent structures would be allowed. He didn't think the City could tell him he couldn't use it for commercial purposes but could put more conditions on it if the Committee wanted.

Chair Wurzbarger asked if there was any opportunity for City use if they kept it and that we would not have if we sold it.

Councilor Calvert didn't think so.

Councilor Ives thought there was probably not a great deal that could be done to improve the view shed in the future.

Councilor Calvert pointed out that the intended use said, "for landscaping and staging area for the business."

Mr. Vigil agreed. It was currently being used for that purpose and likely would continue to be used for that. They cannot expand the building.

Councilor Calvert said Seret & Sons did some landscaping around there and he wondered if their purchase would potentially undo the landscaping or if it would continue to be used that way.

He didn't visualize from the street what it looked like right now. If he was across Alameda, he asked what area they were talking about. He asked if as a condition they should have some analysis and some visuals to look at.

Mr. O'Reilly explained that the way it worked in the past was that staff brings to Public Works and Finance Committees for concept approval and it didn't go beyond that until they had a certified appraisal and if the Committee wanted restrictions on it that would affect the appraisal. It was strangely shaped and comes right up against the building. The City could reserve a five foot strip behind the sidewalk so someday the City could put trees in there. That would be better to do before the appraisal because it was a sale.

Generally, if someone wants to have improvements on the property the City did a licensing agreement but if they used it for commercial purposes it had to be a lease or a purchase. Here, Seret wanted the Council to sell him the property. If the Committee wanted trees or benches, he would recommend taking out a five foot strip.

Councilor Calvert pointed out that if they did that, then the City was on the hook for the landscaping but right now Seret & Sons were storing stuff right out to the sidewalk so it wouldn't be very attractive there or even walking along the river. The City could do that as part of the sale price - lower it and require a landscape buffer. A continuation of that would be appropriate. He didn't think they wanted to see all of those stored materials.

Chair Wurzbarger suggested having a site visit and determine if we want storage there and discuss in more detail what restrictions we could ask for there.

Councilor Calvert also wanted to make sure, if they needed a little extra sidewalk for ADA or something like that, to make sure that was included in any sale - how we define the space.

Mr. O'Reilly was not sure all of that parcel was where storage was located.

Councilor Calvert said the point comes to where his official yard ends and he has stuff outside of it.

Mr. O'Reilly agreed. Staff went back and forth with him so there wasn't anything urgent in this request. If the Committee postponed it to give time for a meeting with Land Use and Legal to determine if we could make restrictions on the rest of his property. This applicant would probably be willing to do landscaping improvements.

Chair Wurzbarger agreed. This would give an opportunity to have a conversation on the best and highest use of this downtown property.

Councilor Trujillo asked if the applicant used the drive off Water Street for his deliveries.

Mr. O'Reilly said it came to our attention that some of the property was used for purposes beyond the agreement with the City - parking vehicles and loading and unloading. He didn't know what the buffer was now - maybe 2-3 feet now and maybe it needed a five-foot buffer. He put in planter boxes to beautify it. Mr. O'Reilly's concern was that the City had to obtain market value of all properties sold or leased and he

would like to talk with Legal and determine the use of other parts of his property.

Councilor Calvert wasn't sure they were talking about the rest of his property. If he wanted to do that on his own was one thing. He asked if the City could require him to do that if we sell it to him and maybe that could be deducted to accomplish the restriction.

Councilor Calvert moved to postpone this request in order to allow Land Use to talk with Legal about the details. Councilor Ives seconded the motion.

Councilor Rivera asked if anyone knew how we obtained this piece of property.

Mr. Vigil said it was dedicated by the State in the 1970's when they were doing rehabilitation in that area. Portions of DeVargas Park were also included.

The motion to postpone this matter passed by unanimous voice vote.

Councilor Calvert said the Committee had to determine if they wanted an audit that was typical (not every single item) or a forensic audit that did every single item.

Chair Wurzburger asked how this came about.

Mr. Pino said it was from discovery that the park bond money could not be used for other purposes. So that meant the City had to find other money to pay for the audit. Staff thought it could be done as part of the City Audit and ask them to take extra sampling. The recommendation was to make it a part of the City's annual audit and give particular attention to more samples in the park bond books.

Councilor Calvert pointed out that the packet referred to exhibits that were not in our packet.

Chair Wurzburger said that would be direction to staff.

Mr. Pino said he had them.

Councilor Calvert moved to approve the amendment to the resolution concurring with staff recommendation to do this audit with the 2012-2013 City audit.

Ms. Amer corrected the motion to say the FY 13 audit. Councilor Rivera seconded the motion.

Councilor Rivera asked when the City audit was done.

Ms. Amer said it was to be completed in December.

Councilor Rivera understood the work would be sampling of more transactions but not line by line.

Councilor Calvert said they could ask for more sampling. Maybe we could specify a percentage. He asked if it was typically 10%. Mr. Pino didn't know.

Councilor Ives recalled the Parking forensic audit cost and pointed out that a forensic audit was done when criminal activity was suspected. He agreed that sampling was appropriate and they could specify more sampling for that bond.

Chair Wurzburger said POSAC had given the concerns. The Committee's next step was to meet with POSAC about it to make sure they were comfortable with that level.

Councilor Calvert said they needed to make sure they got proportionally equal to the rest of the city departments.

The motion passed by unanimous voice vote.

12. DISCUSSION OF THE DRAFT FOR 2015/2019 INFRASTRUCTURE CAPITAL IMPROVEMENTS PLAN (ICIP) (ISAAC PINO)

Chair Wurzburger said they would talk about legislative requests and then review this list of City projects which now totals \$60 million and choose the priority projects that would cost about \$2 million.

Mr. Pino referred to the list from the last meeting that had the three colored categories and the backup sheet that gave a little more for the funding in the future. The legislature prefers to fund projects previously funded and nearing completion (green) such as police station and SWAN Park. The decision they were trying to reach now was prioritization of the top 4-5 projects to present them as city priorities for legislative appropriation, keeping in mind that completion of existing projects were higher.

One project was Houses for Heroes and another was canopies for the parks which Representative. Egolf wanted to sponsor and those had not appeared on the list. He explained that they were prohibited from presenting them as city-wide projects such as for sewer or water. It would go to Finance and then to DFA.

Councilor Ives said he had tried to figure out over the past ten years what had been funded. If staff sent him an email he didn't get it.

Ms. Mossman handed the list out to the Committee members.

Councilor Ives noted that #60 - the storage tank, didn't have a backup sheet. He asked what they had in a previous process for dollars the City might expect and how they should be asking for it.

Mr. Pino wouldn't expect more than \$2 million with a Republican Governor who scrutinizes the list carefully. There was a declaration of what level it would be for revenue and then they get word that revenue would be less. A proven way to address it was to first consider existing projects for continuation at a total of \$2 million. But if we knew a new project could be done for around \$200,000 from beginning to end, it might work to include but now otherwise.

Councilor Ives remembered that last year the Committee broke down the request in that regard and the legislature looked at funding those in different ways. Some smaller ones were appropriated directly by our own senators and representatives from their discretionary funds. He next asked if they were looking at the larger pool or at those smaller projects. The smaller ones might be considered in that secondary tier.

Mr. Pino said they had big projects as well as smaller ones. In this list were items in green and items in blue that were funded last year.

Chair Wurzburger said their list was not in color.

Councilor Calvert pointed out that they were not only capital outlay but in the past the City had severance revenue as a source for projects. Whatever the state budgets would provide a clue. They've been forecasting higher revenues because oil and gas revenues were up but the closer we get to the session was when our delegation would be asking if there were smaller projects they could help fund in their district.

Chair Wurzburger asked if by the next meeting the Committee could get to a consensus at around \$2 million and then have smaller ones as back up.

Councilor Ives knew the City had gone to the Water Trust Board in times past. That board was proposing a lot of changes that would make long-range projects more difficult - more politicized. Buckman had previously been funded through the Water Trust Board. He asked what other funding mechanisms might come into play, understanding there might be different funding sources.

Mr. Pino thought the City needed to have the local delegation point those out.

Councilor Ives thought weighing the urgency would be important and he didn't have a sense of that or of other forces on it.

Mr. Pino said we have to present our priorities and let the delegation figure out the sources. Guiding them makes no sense because they were going to be the sponsors.

Councilor Ives agreed that made sense.

Councilor Calvert said if the delegation found other sources for a project the City would want to have alternate capital outlay projects for them in that event.

Councilor Calvert shared his criteria list with the Committee. It included: Is this essential (absolutely needed now)? Is this finishing something already begun? Is it something urgently needing to be fixed? Is it something that needs to be done right now? Circumstances could change over time so we want to choose projects not affected by those changes.

Councilor Rivera pointed out regarding the police station that money was given last year and no construction had yet started. So he asked if the Committee should still consider it.

Mr. Pino thought so since the City has a good track record for completing its projects. It would be incumbent on the City to produce the schedule for them though.

Councilor Rivera asked if there were any projects in green that would carry over in multiple segments.

Mr. Pino said that was true for the Police Station, SWAN Park, and the Senior Center.

Councilor Rivera reasoned that it made sense to continue to ask for money for these three although we haven't spent the money yet.

Mr. Pino agreed.

Councilor Rivera asked how many of the future improvements needed could be ready by January.

Mr. Pino said he would have to check on that. SWAN Park design should be finished by next month and phase one construction could begin but the City was way short of money to do that.

Chair Wurzbarger pointed out that was an \$8 million project and the City put \$5 million toward construction that we haven't started spending so the question was whether we could spend that next summer.

Councilor Rivera recalled the legislature gave only \$35,000 for it and the City should spend that first before spending the \$5.2 million of bond money.

Mr. Pino said those were the things to be weighed in the balance. Last year the City received money for La Familia, the Santa Fé Rodeo, the Boys and Girls Club, Farmer's Market and the Rape Crisis Center.

The City was responsible for overseeing the spending of that money.

Councilor Ives asked what the total costs were on SWAN Park.

Mr. Pino said it was \$15 million.

Councilor Ives noted in looking at the list, for those funded in the past that there was no sheet for 2012, one for 2011 and nothing for 2010. He asked where to find 2012.

Mr. Pino clarified that the top sheet was from David Chapman and the sheet that followed was provided by DFA. ICIP funding was on the sheets provided last time and gave the totals from 2012- 2013.

Councilor Calvert noted that Buckman Water Transmission was on the green part but on the sheets that was mostly storage for treated water and another tank - Dempsey tank up by Sierra del Norte. There was another one by the hospital. Those three were geared toward storage and he had asked Mr. Snyder which one he would pick. He said the La Tierra tank was the most needed. What he didn't ask was whether all of them were in the financial plan with the water company. If they were then that cost would be already covered in another way.

Councilor Calvert favored just using items in the green: Police Station, SWAN and possibly the Water Historic Park - all of which would be finishing up.

Councilor Rivera said everything in green were city projects. Nonprofits had to be on the ICIP to get funding but they had to do all the legwork.

Mr. Pino said they get the same scrutiny as the city projects.

Councilor Rivera asked if they could have two lists of ten and include the nonprofits. The City would benefit from everything in green but to give others permission to ask for funding was also important.

Chair Wurzbarger suggested it would be helpful to have Mark Duran talk to them about that. In the past she understood that to be a different track. Sometimes those were introduced by the legislators and not coming from the City per se.

Councilor Calvert said the Rodeo was up in the green but was more initiated by another entity instead of the City. We passed a resolution in support of it and even committed some planning money toward it. We didn't have to commit money to them but the nonprofit often asked for support of the organization resolution.

Councilor Rivera said the MRC Soccer Complex name change should be made. He asked if the City should include some of those partner projects.

Mr. Pino thought the challenge would be what process the City would use. He could envision people lining up for miles to get a pass-through agreement once they had a sponsor.

Councilor Rivera asked how the Rodeo got on the green.

Mr. Pino said it was because they were a continuing project.

Chair Wurzburger pointed out that the MRC was a city project. It was a city complex.

Regarding the criteria, at least historically and may be just as relevant now, if the Committee looked at this pot of money from the legislature, it adds to our own CIP. In terms of facilities, it was useful to think about only \$2 million to ask for out of \$ 60 million in needs. One of the criteria was finishing a project already begun. It might even be #1.

Councilor Calvert agreed. It had to be #1 with the governor. Governor Martínez wants to see them finished.

Chair Wurzburger said her second criterion was that regional or city-wide was bigger than a park. The third criterion was the notion that some portion (small project) that would make a difference would have remaining funds. The fourth was something very urgent that has to be done and no money for it. Fifth was the notion of other possible sources of funding. Those were the five she suggested the Committee think about.

Councilor Trujillo asked if the Cerrillos Road project was going out to bid in 2014.

Mr. Pino agreed but not start until 2015.

Chair Wurzburger asked if there were any other criteria to think about.

Councilor Calvert thought we were going to come up with the list.

Councilor Trujillo said they should start with the green.

Mr. Pino said Ms. Mossman reminded him that first order of business was to make sure we have everything on the list.

Chair Wurzburger agreed.

Mr. Pino said even if they added another 20 projects. He needed to have them all on the list.

Councilor Ives asked to add shade structures for parks and trails. Mr. Pino agreed.

Councilor Calvert said the list should identify the specific facility for repair. "Facilities" was too broad a term.

Chair Wurzburger asked that staff clarify that.

Chair Wurzburger asked the Committee to narrow down the list now and start with the green.

The following items were definitely kept on the priority list:

Police Station - yes.
SWAN Park - yes
Water History Museum - yes.
MRC - yes
Downtown Bridge improvements - yes.
La Tierra Tank - maybe.
Facilities - yes but more specific.
South side Library lightning protection - still considering.
Salvador Perez Pool - maybe
Ft. Marcy - yes (part of Facilities).
ITT Generator -South side Software - Councilor Ives said yes.
Rufina Street sewer - maybe
Traffic Study - St. Michaels - yes.
GCCC - include in facilities.
South side Transit Center - yes.
Fire Station - W - yes.
Airport - Chair Wurzburger reported that a plan would be coming forward for temporary portables. Yes for emergency.
Evidence Storage - should be included in the ongoing project.

Councilor Calvert asked if the City wanted to advocate for the Community Center for Addictions Program. It was left on the list as a question to them.

Chair Wurzburger asked staff to put the criteria on these projects for the next meeting. She thought they were through for today.

Mr. Pino asked if each member could give him something on their choices by Friday either by email or phone call and he would tally them.

Councilor Calvert asked Mr. Pino to email the Committee the narrowed down list.

Councilor Trujillo asked if Mr. Pino could break out those projects that fit the criteria.

Chair Wurzburger agreed. Using the criteria, staff could then provide their assessment of the top five and the Committee's homework was to make their own evaluation.

Councilor Rivera said they just chose 15, not including facilities.

Councilor Calvert asked Mr. Pino to provide the top 4 projects on price or urgency.

Chair Wurzburger said staying within the \$2 million the Committee would narrow the list down to four

projects at the next meeting.

Councilor Calvert wanted to keep the list for the City but not the legislature and then rank the alternates.

Chair Wurzburger said the legislature always wanted to know our top 2-3 so we give them five. And we could get Mark Duran's advice on it.

Councilor Calvert said they usually gave the top five at the legislators' meeting.

Councilor Rivera thought the top 3 in green were pretty solid so they would only have two more to choose from the list.

13. MATTERS FROM THE STAFF

There were no matters from the Staff.

14. MATTERS FROM THE COMMITTEE

Councilor Ives asked Mr. Pino when the speed signs would be put on West San Mateo.

Mr. Pino said it would be done right away.

Chair Wurzburger said they were supposed to have a meeting on the Sawmill flooding.

Councilor Ives agreed. He had requested a date and time for us to set it up.

Mr. Pino indicated there were a number of claims filed already.

Councilor Ives said there was also flooding behind Whole Foods. He had a poster board with a proposal in cooperation with local businesses there to solve the water flow issues on that street.

Councilor Trujillo asked if the scoreboards in our parks were owned by the City or by the leagues. One league wants to borrow a scoreboard and they were told another league owned them.

Mr. Pino said he had directed the Parks Department to just get another set of controls while trying to ascertain the ownership but meanwhile it just seemed more prudent to get another set.

Councilor Trujillo thanked him.

Councilor Rivera asked Mr. Pino to thank the parks staff for taking care of the sidewalk issues at Tierra Contenta now that parents were walking their kids to school.

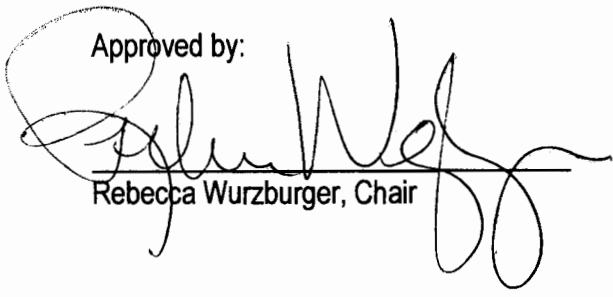
Chair Wurzburger said the Committee members were delightful to work with.
