MINUTES OF THE CITY OF SANTA FE PUBLIC UTILITIES COMMITTEE Wednesday, October 2, 2013

1. CALL TO ORDER

A meeting of the Public Utilities Committee was called to order by Councilor Christopher Calvert, Chair, at approximately 5:00 p.m., on Wednesday, October 2, 2013, in the Council Chambers, City Hall, Santa Fe, New Mexico.

2. ROLL CALL

VOTE: The motion was approved on a voice vote, with Chair Calvert, Councilor Dimas and Councilor Rivera voting in favor of the motion, no one voting against, and Councilor Trujillo abstaining.

CONSENT DISCUSSION

7. UPDATE ON CURRENT WATER SUPPLY STATUS. (VICTOR ARCHULETA)

A copy of the *Weekly Water Report Week of September 22, 2013*, is incorporated herewith to these minutes as Exhibit "1."

Victor Archuleta presented the information in Exhibit "1." Please see Exhibit "1" for specifics of this presentation.

The Committee commented and asked questions as follows:

Councilor Trujillo said there is water running down the river and there was discussion about possibly putting on the Fishing Derby this year, noting staff is in discussions with the State Game & Fish Department. He asked Mr. Hook what the time frame would be, if Game & Fish approves the Fishing Derby.

Alan Hook said he contacted Game & Fish last Friday, but he hasn't heard from them today. He said they were going to look at habitat and water quality. He said Game & Fish told him as long as there is a duration of flow and adequate flow, which the City can have, they were okay with stocking recreational fish. He said they are looking, tentatively, at the weekend of October 12, 2013. He said this would give plenty of lead time, and afterward if there is a salvage order from Game and Fish that there would still be a substantial flow through the month.

Mr. Hook said he also spoke with City Parks about the sand bags, and Brian Drypolcher said there are plenty of sand bags. He said YouthWorks is available to volunteer to help us install those for the ponding of the fish at that time.

Councilor Trujillo said he would like to look at having the derby at the previous location near the State Land Office, and not at DeVargas Park where it was held last year. He said the location by the Land Office was a better location and allowed more people to have access to the River. He said unfortunately, someone cut too much of the vegetation which he doesn't want to have happen this year.

Mr. Hook said he has contacted Brian Drypolcher and Ben Gurule of Parks. Their only concern is there is new seating along the River since the sidewalk has been redone. He said the area by Don Gaspar would be fenced-off, but there would be access below the wall to the River's edge so people and families can fish along the River's edge from Don Gaspar to Old Santa Fe Trail, so, he doesn't see a problem with that location. He said the last step would be contacting the State Land Office, commenting they always have been amicable to the event, and he sees no problem there.

- Councilor Trujillo asked Mr. Hook to keep him informed on the progress, commenting, "I hope this comes to fruition."
- Chair Calvert said previously we have done the Fishing Derby by Resolution, and asked Mr.
 Hook if he can "iron this out" with the City Manager, or does it have to come before the City Council.

Mr. Hook said he can't speak for the City Manager, but it is his understanding the City Manager can approve it.

Mr. Schiavo said in view of the dollar amount involved, which would just be City manpower to set up the site which would involve a very few additional hours of compensatory time, and he believes the City Manager could approve it.

- Chair Calvert said the Council has endorsed the Derby in the past, so the City Manager has
 that to rely on, commenting he doesn't want to speak for the other Councilors, but the City
 Manager should be able to approve it.
- Councilor Trujillo said he will speak with Brian Snyder about this as well.
- Councilor Dimas believes the Derby should be for Seniors as well.
- Councilor Trujillo said it is an open body of water and by law in New Mexico, it has to be open to everybody. He said in the past they have asked people not to fish until afternoon and give the kids the chance to fish in the morning, but that hasn't worked. He would like staff to talk to the Game & Fish people to see if they would set an age limit on a section of the River.

Mr. Hook said Game & Fish has the discretion to do that. He said they probably can have a Fish Warden at the site.

 Councilor Trujillo said last Saturday there was free fishing throughout the State, and asked Mr. Hook to talk to Game & Fish about an exception for licences for kids for that section of the Santa Fe River for that day.

Mr. Hook said he would do so.

- Chair Calvert commented on the difficulty of policing that event.

Chair Calvert noted there is correction to the figure in paragraph 3, which should be \$115,419.13 instead of \$124,869.07, and on page 2 in the last paragraph the figure should be \$324,983.74 instead of \$324,564.74.

MOTION: Chair Calvert moved, seconded by Councilor Trujillo, to approve this request, with the corrections he proposed.

VOTE: The motion was approved unanimously on a voice vote.

Councilor Rivera recused himself from participating on the item because his a nephew is a bidder, and left the room.

Cindy Padilla presented information from her Memorandum of October 2, 2013, which is in Committee packet, noting staff recommends the selection of Mr. G's Santa Fe Recycles which the low bid. Please see this Memorandum for specifics of this presentation.

Councilor Trujillo asked Ms. Padilla if we have sent any of the dumpsters to auction.

Ms. Padilla said not since she has been back with the City. However, she understands they have been taken to auction in the past, noting it would problematic in terms of the space, transportation and the funding.

Councilor Trujillo said we now have the option to go to on-line bidding, which he has discussed with Robert Rodarte. He said perhaps the next time we might put the item on the on-line bidding site, and do a comparison. He said the auctions are worldwide. He said we might get a better bid.

Ms. Padilla said this is a good idea, which would give us several opportunities to get rid of the dumpsters.

Councilor Trujillo pointed out that with on-line bidding, people pick them up in Santa Fe and there is no cost to the City for the pick up of the dumpsters.

Ms. Padilla said they do go to auction on all of their collection units, so this definitely makes sense.

MOTION: Councilor Trujillo moved, seconded by Councilor Dimas, to approve this request.

VOTE: The motion was approved on a voice vote with Chair Calvert, Councilor Trujillo and Councilor Dimas voting in favor of the motion, no one voting against, and Councilor Rivera recused

Ms. Padilla noted the pink shirts and blue bags which were given to each Councilor this even ing. She said the staff will be wearing the pink shirts saying "Garbologist," on Friday in honor of breast cancer survivors and family and friends we have lost to breast cancer. She said the blue bags are the reusable bags which they purchased for the implementation of the reusable bag ordinance. She said they putting together a distribution plan and strategy for the effective date on February 27, 2014, and they are working on the campaign to get out the word. She said there will be a radio ad in October to get people started thinking about reusable bags.

Ms. Padilla invited the Committee to participate in the Keep Santa Fe Beautiful Annual Fundraiser on October 19, 2013.

ITEM AND ISSUE

Approval of Amendment No. 1 to the On Call Engineering Services agreement (Item #12-0970) dated November 15, 2012 with Santa Fe Engineering Consultants, LLC (SFEC) in the amount of \$324,983.74 plus gross receipts tax and approval of the Budget Adjustment Request (BAR) is requested.

BACKGROUND AND SUMMARY

Reservoir Infrastructure Improvements Phase 1 CIP No. 3038 includes outlet works improvements at McClure & Nichols Dams and the rehabilitation of the existing Canyon Road Water Treatment Plant (CRWTP) raw water supply pipeline.

\$FEC prepared engineering plans and specifications to replace the existing vertical intake towers at McClure & Nichols Dams with new inclined intake structures and construction is underway. The Office of the State Engineer (OSE) requires that inclined intake structure construction be certified by a qualified professional engineer as condition to the permit to alter or rehabilitate the dams. The cost for SFEC to provide onsite construction monitoring is \$124,869.07 15,419.13 plus GRT and is included under Exhibit C of the On Call Engineering agreement.

SFEC prepared engineering plans and specification to rehabilitate the existing 24 inch CRWTP pipeline in the current alignment within or along the Santa Fe River. At the request of The Nature Conservancy and Audubon New Mexico (Randall Davey Center) to consider replacing the pipeline in an alignment outside of the Santa Fe River and as a result of winter damage to the existing pipeline, the Water Division made the decision to construct a new pipeline in or along the existing Nichols Dam service road and in the existing upper Canyon Road watershed access. The cost for SFEC to prepare pipeline engineering plans and specifications is \$209,564.61 plus GRT and is included in Exhibit D of the On Call Engineering agreement.
