#### 1. Call to Order

The meeting of the Arts Commission was called to order by the Chair, Kirk Ellis at 4:00 pm. Verbal roll call constituted a quorum.

#### 5. Fiscal Report – Debra Garcia y Griego

We are down 4.5% YTD. We know that July was over inflated due to late payments and that is making this July artificially deflated. August was down 3.4% but then we go back to September that was down 13% and October is up 16%. Again, the thought is it is the late payments.

Ms. Sakiestewa had asked how caught up we were on the delinquent lodgers tax. Ms. Garcia y Griego did not have information available at this time.

Ms. Scheer asked; is the lodger's tax a YTD 2013 or FY? Ms. Garcia y Griego responded, Fiscal Year. If this FY in June and this grant cycle that we are approving people this May, we are down 4.5% and is this used to approve or allocate in the May cycle? Ms. Garcia y Griego stated that they allocate on an estimate and they pay on actual so this money has already been allocated for the contracts that are in place this year.

#### 7. Report of Director

Creative Tourism program is moving along for the year and it too operates on the city FY. In workshop sales since July 1, 2013 - \$17,725 are directly in to the hands of local artist. Website hits to the website are up by 15.71%, the website was redesigned and re-launched and staff is working on the March event which is the Spring Break – Come and Stay at a Hotel and Take a Class.

Poet Laureate – John Davis sent an e-mail to Ms. Garcia y Griego and Mr. Davis now has a monthly column in the Santa Fe Reporter. That will be new exposure for the

program. He has his second reading scheduled for Sunday the 24<sup>th</sup> at 3:00 pm at the IAIA Life Long Learning Center.

Office Move – Located in the business center. The new guaranteed date for the move to be complete is November 22, 2013.

We have completed interviews for the Program Manager. Hope to have person in this position by the beginning of December.

**Extra, Extra!** The locked-out Minnesota Orchestra is all but dead. New York City Opera has filed for bankruptcy. I know, you've heard it before, but bear with me, OK? What we're seeing here is not a string of isolated high-culture horror stories but something far more significant—something that requires a different kind of response.

Everyone who keeps up with the National Endowment for the Arts' Survey of Public Participation in the Arts data knows that high-culture attendance numbers have been shrinking across the board for more than a decade. Opera, theater, dance, symphony orchestras, even big-city art museums: All are drawing smaller crowds. So what's the larger meaning of these figures? Three recent articles that view the problem from different perspectives come to similar conclusions:

- Says Jaime Weinman in the Canadian magazine Maclean's: "The lack of funding for orchestras and opera companies may already be raising the question of whether North America has too many of them—or whether, as with other institutions, there should be more streamlining and consolidations.... The Baby Boomers who are becoming the new generation of old people have grown up with rock music, and may not be very likely to invest in classical music";
- Theater blogger Howard Sherman sees much the same thing happening in his area of expertise: "While in the first half of my life I watched the burgeoning of the resident theatre movement, which in turn seeded the growth of

countless smaller local companies, my later years will see a contraction in overall production at the professional level; it's already begun, as a few companies seem to go under every year and have been for some time";

• Michael Kaiser, president of the Kennedy Center, writes in the Huffington Post that we may be "witnessing a major transition in the arts from regional organizations to fewer mega-organizations with the sophistication to mount large-scale productions, to market them well and to raise large sums of money.... Does this spell the end of the mid-sized regional arts organization? Will it be increasingly difficult to build

an audience and a donor base for a \$10 million arts organization? Will boards simply give up trying to fund ever-increasing budgets? Will many of these organizations shrink, or disappear entirely?"

Here's another question: Might it be possible that some of them should disappear?

In 2010 on these pages I wrote "The Zero Option," in which I asked whether regional orchestras still make artistic sense. "For a fast-growing number of Americans, the answer is no," I replied, arguing that many such orchestras were in the process of being rendered obsolete by digital downloading, which makes it possible to hear the classics whenever and wherever you want. Similar forces are at work in the other arts. Live theater competes with cable television. Live opera competes with closed-circuit simulcasts. Everybody competes with the iPad—and with the now-crushing dominance of pop culture over high culture.

Is the situation hopeless? By no means. But how many older fine-arts organizations are capable of the radical innovation that's necessary to survive in a world of ceaseless competition? Middle-age arts administrators, after all, cut their teeth during the fat years when performing-arts centers and art museums were opening all over America. Alas, they've survived into an ice age of economic contraction, and some of them haven't had an original idea since 1975.

It's in the nature of aging bureaucracies—and nothing is more bureaucratic than a solidly established arts organization—to place self-perpetuation at the top of their to-do lists. Not surprisingly, such bureaucracies tend not to be very good at thinking of new ways to do what they're already doing, much less of brand-new things to do. Most of the people who work at (say) Lower Podunk Repertory Theater—which opened its doors 35 years ago, built a two-theater complex in 1998 and won a regional-theater Tony in 2002—undoubtedly take it for granted that LPRT deserves to continue giving performances for the next 35 years. Maybe it does; but it could also be that LPRT is creatively exhausted and chronically mismanaged, and that the men and women who run it are no longer capable of keeping up with changing times.

According to management guru Peter Drucker, hiring an effective successor to a departing CEO is "the ultimate test of any top management and the ultimate test of any institution." When it comes to arts organizations, I'd say that the ultimate test is knowing when an institution is suffering from a case of creative and administrative sclerosis that is about to become terminal, then doing something about it, as the Metropolitan Opera is endeavoring to do. In order to survive, such institutions will have to constantly reexamine their missions and adapt to the brutal challenges of American culture in the 21st century. Above all, they must learn the terrible lesson of New York City Opera: No arts organization is too big, too old or too famous to fail.
