ADVISORY BOARD OF DIRECTORS

March 19, 2014

A meeting of the City of Santa Fe Division of Senior Services Advisory Board of Directors was called to order by Gilbert Alarid at 9:30 a.m. on this date at the Mary Esther Gonzales Senior Center, 1121 Alto Street, Santa Fe, New Mexico.

Roll Call indicated the presence of a quorum for conducting official business as follows:

INVOCATION

Invocation was led by Tonie Ann Gallegos.

PLEDGE OF ALLEGIANCE

The Pledge of Allegiance was led by Bernardo C de Baca and was recited by all present.

APPROVAL OF AGENDA

The agenda was amended – Item VI, C (2015 Capital Outlay Request) was changed to read: (2014 Capital Outlay Request Update)

Ms. Trujillo moved to approve the agenda as amended. Ms. Gonzalez seconded the motion. The motion passed unanimously by voice vote.

APPROVAL OF MINUTES: February 19, 2014

Ms. Trujillo moved to approve the Minutes of the February 19, 2014 meeting as submitted. Ms. Gonzalez seconded the motion. The motion passed unanimously by voice vote.

DSS DIRECTOR'S REPORT

Mr. Vialpando and the Board Members extended their condolences to the family of Mary Louise Giron on their loss.

a) Program Units of Service

Mr. Vialpando gave an update on the Program's Units of Services as follows:

- Based on projections, the DSS is over in congregate meals by 2,196 units of services and over by 4,041 in Home-Delivered meals.
- The DSS has seen a decline in transportation units of services of 799 units mainly because they have had some vacancies in the transportation section. The DSS recently hired a driver and presently has one vacancy for a transit driver. The position was advertised and recently closed and the DSS is waiting for the list of eligible applicants so they can begin the hiring process.
- The DSS is over in respite unit of services by 107 hours and down by 8 hours in homemaker services.

b) City of Santa Fe Budget Request/FY 2014-2015 Update

Mr. Vialpando reported that the Division of Senior Services was asked to stay at a flat budget for FY 2014-2015. The General Fund for the Division of Senior Services is at \$2,092,352. This is what the DSS receives from the City of Santa Fe for the senior

programs. The State contributes \$716,876 towards the senior programs and the Federal contributes \$695,535. The total budget for the Senior Programs for FY2014-2015 is \$3,504,763.

Mr. Vialpando mentioned that the DSS has put in a expansion request to hire a Transit Operator for the Transportation Section to address the growth in this program, as well as a Meals on Wheels part-time driver. The total expansion request that was submitted to the City of Santa Fe was in the amount of \$86,479.

c) 2014 Capital Outlay Request Update

Mr. Vialpando said last month he reported that the DSS was looking at a little over \$900,000 for the 2014 Capital Outlay request; however, \$1,078,380 was approved for the City of Santa Fe Capital Outlay request as follows:

Mr. Vialpando noted that these are all pending approval via the 2014 General Obligation Election in November.

In-Home Support Committee

Ms. Sanchez moved to accept the In-Home Support Committee monthly report as submitted, and include it as a part of the public record with the Minutes. Ms. Lucero seconded the motion. The motion passed unanimously by voice vote.

Foster Grandparent / Senior Companion Programs Committee

Ms. Gallegos moved to accept the Foster Grandparent/Senior Companion Program Committee monthly report as submitted, and include it as part of the record with the Minutes. Ms. Sanchez seconded the motion. The motion passed unanimously by voice vote.

Transportation and Nutrition Committee

Ms. Lucero moved to accept the Transportation and Nutrition Committee monthly report as submitted, and include it as a part of the public record with the Minutes. Mr. C de Baca seconded the motion. The motion passed unanimously by voice vote.

Senior Olympic Committee

Ms. Trujillo moved to accept the Senior Olympics Committee monthly report as submitted and include it as a part of the public record with the Minutes. Mr. Schocke seconded the motion. The motion passed unanimously by voice vote.

UNFINISHED/OTHER BUSINESS

Mr. Vialpando noted that staff is working on a report that was requested by the City Manager on the accomplishments and anticipated or upcoming projects for the Division of Senior Services. He offered to give an update to the Board at the next meeting.

Mr. Vialpando said they are also working on the 2015 Legislative Request for operating dollars for the Senior Programs. This request will be submitted to the AAA and is due on March 24th. The DSS will be requesting funding for a cook at the Villa Consuelo Senior Center and additional funding to address inflationary costs for food and fuel.

NEW BUSINESS

a) Food Distribution-Ventana de Vida Senior Center

Ms. Gonzalez announced that the Food Distribution Center is going to start distributing food at the Ventana de Vida Senior Center every Friday morning at 10:00 a.m. This will start next Friday.

Ms. Trujillo mentioned that St. John's Catholic Church also has a food distribution of non-perishable food every third Friday from 3:00 p.m. to 4:00 p.m. Everyone is welcome and there is no age limit.

b) New Mexico Conference on Aging

Lugi Gonzales noted that the New Mexico Conference on Aging is scheduled for August 19th and August 20th, 2014 at the Isleta Resort & Casino Conference Center in Albuquerque. The New Mexico Conference on Aging is awarding 10 full scholarships and 20 partial scholarships to assist adults age 55 or older who otherwise would not be able to attend the conference. Full scholarships include conference registration fees, lodging and meal costs. An individual must live 80 miles or more from the conference to apply for a full scholarship and partial scholarships include registration fees and a lunch gift card. The deadline for scholarship nominations is May 19, 2014.

Mr. Vialpando said transportation will be provided to the Conference.

Lugi Gonzales announced that there will be a Caregiver Support Group session on "How to Deal with Care Giving Guilt Warning Signs & Laughter Yoga" on April 15, 2014 from 1:30 p.m. to 4:30 p.m. at the Mary Esther Gonzales Senior Center. This Session will provide education and emotional support to adults who deal with stress associated while providing specialized care for homebound individuals. Refreshments will be provided. For reservations, people can call Theresa Trujillo at 955-4745.

February units of service are as follows:

- Homemaker 706 hours to 91 seniors
- Respite 795 hours to 42 caregivers
- Equipment 31 units
- Nutritional Supplements –112 6-packs (28 cases)

Year to date, we are over in Respite hours by 107 hours and short in Homemaker hours by 7.75 hours. IHSS providers took off a total of 218 hours in February.

One homemaker has transferred from our section effective February 14 leaving us short-handed; the position has been advertised and closed on Monday, March 17.
