

April 16, 2014

A meeting of the City of Santa Fe Division of Senior Services Advisory Board of Directors was called to order by Andres Romero, Chairman at 9:30 a.m. on this date at the Mary Esther Gonzales Senior Center, 1121 Alto Street, Santa Fe, New Mexico.

PLEDGE OF ALLEGIANCE

APPROVAL OF AGENDA

Mr. Gonzales moved to approve the agenda as published. Ms. Gonzalez seconded the motion. The motion passed unanimously by voice vote.

APPROVAL OF MINUTES: March 19, 2014

Ms. Lucero moved to approve the Minutes of the March 19, 2014 meeting as submitted. Ms. Sanchez seconded the motion. The motion passed unanimously by voice vote.

DSS DIRECTOR'S REPORT

Mr. Vialpando and the Board Members extended their condolences to the family of Louise Kippert on their loss. Louise Kippert was a valuable employee of the Division of Senior Services for over 20 years. She will be dearly missed.

a) Program Units of Service

Mr. Vialpando gave an update on the Program's Units of Services as follows:

- Based on projections, the DSS is over in congregate meals by 3,431 units of services and over by 2,586 in Home-Delivered meals.
- The DSS has seen a decline in transportation units of services of 824 units
- The DSS is over in respite unit of services by 1,510 hours and down by 71 units of services for homemaker services.

b) 2015 Capital Outlay Request

Mr. Vialpando reported that the Division of Senior Services is looking at a little over \$1 million for the 2015 Capital Outlay request. The total request of \$1,174,910 is a combination of capital improvement projects as follows:

Equipment – Meals

a) Complaint from Virginia Soto

a) Vial of Life Project

Chairman Romero distributed information on the Vial of Life Project that is sponsored by the American Senior Safety Agency. He asked the Board Members to fill out the Vial of Life Form that will aide EMS in the event of an emergency. Board Members were asked to put a copy of the Vial of Life Form in a plastic baggie and place it on the refrigerator door. They may also consider placing the following items in the baggie:

- Copy of EKG
- Living Will or Equivalent
- DNR (Do Not Resuscitate)
- A recent picture
- Any other items that they feel would be important

Decals of the Vial of Life Project were also distributed. These can be placed on the front door at eye level so it can easily be seen by anyone responding to an emergency.

Ms. Lugi Gonzales will store the information on individual flash drives for the Board Members.

COMMENTS FROM THE FLOOR

Music at Pasatiempo Senior Center

Ms. Gonzalez mentioned that several people have approached her about having music on Wednesdays at the Pasatiempo Senior Center because the band that used to play there has stopped playing.
