**A RESOLUTION**

**REPEALING RESOLUTIONS 2000-47, 2003-18, AND 2010-68, WHICH CREATED AND AMENDED THE SANTA FE REGIONAL JUVENILE JUSTICE BOARD.**

**WHEREAS**, the Governing Body desires to streamline the process of addressing the most urgent matters affecting children, youth, and young adults in the Santa Fe community; and

**WHEREAS**, the Regional Juvenile Justice Board was created in 2000 to compliment the Children and Youth Ordinance and with the intention of seeking outside funding sources to carry out the planned objectives of the Children and Youth Commission to address juvenile delinquency; and

**WHEREAS**, the Children and Youth Commission was created in 1998 to identify and recommend pathways to promote the healthy development of young people living, attending school, and working in the City of Santa Fe; and

**WHEREAS**, a companion bill proposes to expand the membership of the Children and Youth Commission to incorporate the incumbent members of the Regional Juvenile Justice Board so they can continue to provide their input on policies and programs affecting young people in

1 Santa Fe; and

2       **WHEREAS**, the members of the Regional Juvenile Justice Board may continue to  
3 provide their expertise on addressing issues facing the City’s youth because the Commission also  
4 focuses on “identify[ing] and recommend[ing] to the governing body existing legislation,  
5 policies, and programs that promote the health development of young people”; and

6       **WHEREAS**, the repeal of the Regional Juvenile Justice Board and subsequent expansion  
7 of the Children and Youth Commission is intended to better serve Santa Fe’s youth by allowing  
8 all members to work collectively and collaboratively to apply for funding, develop policy, and  
9 implement strategies; and

10       **WHEREAS**, the incredible and valuable work by the Regional Juvenile Justice Board is  
11 intended to continue as a priority area of the Children and Youth Commission and to be included  
12 in the Children and Youth Strategic Plan in future years.

13       **NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE**  
14 **CITY OF SANTA FE** that Resolutions 2000-47, 2003-18, and 2010-68, which created and  
15 amended the Santa Fe Regional Juvenile Justice Board, are hereby repealed.
