17 2019/2020 to be approved by the Governing Body; and

19 compliance with the State Open Meetings Act: and

20 **WHEREAS**, it is the majority opinion of this Governing Body that the proposed capital
21 budget meets the requirements as currently determined for fiscal year 2019/2020.

22 **NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE**
23 **CITY OF SANTA FE** that the Governing Body hereby adopts the attached capital budget as to
24 funds, categories, and departments and respectfully requests approval from the Local Government
25 Division of the State of New Mexico Department of Finance and Administration.

2 the policies included in the fiscal year 2019/2020 budget.
