#### DISCUSSION ON FUNCTION OF THE TREE BOARD

Chair O'Brien introduced John McAndrew.

Chair O'Brien gave an overview of what the Tree Board is and does.

Ms. Schruben gave an overview of the Land Use Code.

Chair O'Brien introduced Richard Thompson and Mr. Thompson gave a brief update on the Parks Department as it relates to the Tree Board and the PARC

There was discussion about the relationships between the City, the Parks and Recreation Department, PARC and the Tree Board.

#### 5. OLD BUSINESS AND POSSIBLE ACTION

#### A. TREE INVENTORY

- Ms. Touchett said they are finishing up their last park, Las Acequias.
- Ms. Schruben reported that she is working on inputting information on the older inventories that were done such as Ragle Park.
- Ms. Touchett said the upper part of Candelaro Park still needs to be entered. Nancy entered the lower part.
- Mr. Thompson said the Park acreage includes the MRC. It is 500 irrigated acres.
- Ms. Touchett said we should figure out how the City is going to incorporate this information.
  - Mr. Thompson said that Planet Geo could help.
- Ms. Touchett said she doesn't want to spend time and effort until we get some pathway to use the data.
- Mr. Neal said they talked earlier about having a website. Is part of the goal to have the inventory on the website.
  - Ms. Touchett said the website committee would talk about that.

#### B. CITY TREE MAINTENANCE PLAN

Chair O'Brien asked if there is anything the Board should be doing.

- Mr. Neal asked if Richard was supposed to be doing that
- Mr. Thompson said no.
- Mr. Neal asked if there's a plan to do protective maintenance.
- Mr. Thompson said yes and no. It is one of their charges.
- Ms. Touchett said Richard was going to talk to IT.
- Mr. Thompson said he sent an email to Josh Elicio, City IT.

There was a discussion around the library, raised bricks and the removal of trees.

Ms. Schruben said the Tree Board should send one representative to the Library Board to talk about this issue

**MOTION:** Member Varvil moved to form a subcommittee to help Public Works make a plan to deal with the trees outside of the Main Library, with a second from Member Touchett. The motion passed by unanimous voice vote.

A subcommittee was formed including members Neal, Touchett and Wolfe.

Mr. Neal asked Richard if he's working with Public Works.

Mr. Thompson said he told them not to cut the roots. They will not remove trees, but it will be an adaptive
