Mayor and Members of the City Council:


I propose the following amendment(s) to Resolution No. 2021-__ :

1. On page 3, line 24 *insert* the following new paragraphs:
“**BE IT FURTHER RESOLVED** that the City of Santa Fe supports and endorses any legislation that slows down the timeline for eviction and improves opportunities for mediation between renters and landlords.
BE IT FURTHER RESOLVED that the City of Santa Fe supports and endorses any legislation that replenishes and seeks a reoccurring funding source to support MFA's Housing Trust Fund.”
2. On page 3, line 24 *insert* the following new paragraph:
“**BE IT FURTHER RESOLVED** that the Governing Body supports and endorses the establishment of a regional drug treatment facility that would serve the residents of Santa Fe and northern New Mexico.”
3. On page 4, line 13 *insert* the following new paragraph:
“**BE IT FURTHER RESOLVED** that the City of Santa Fe continues to support state wide paid sick leave legislation, as reinforced by the City’s Resolution No. 2021-11 unanimously passed in 2021.”
