5 AN ORDINANCE

6 RELATING TO SEWER SERVICE CHARGES – AMENDING RULE 8 OF EXHIBIT A  
7 OF CHAPTER 22 SFCC 1987 TO INCREASE THE MONTHLY SERVICE FEE AND  
8 MONTHLY USAGE FEE FOR THE WHOLESALE RATE; RELATING TO EXTRA-  
9 STRENGTH SURCHARGES – AMENDING RULE 12 OF EXHIBIT A OF CHAPTER 22  
10 SFCC 1987 TO INCREASE THE MASS BASE CHARGE; AND MAKING SUCH OTHER  
11 CHANGES AS ARE NECESSARY.

13 BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF SANTA FE:

14 Section 1. Rule 8 A. of Exhibit A of Chapter 22 SFCC 1987 (being Ord. #1997-  
15 3, Exhibit A, as amended) is amended to read:

16 8. Sewer Service Charges.

17 A. Connected to City Sewer

18 1. Single Family Residential Sewer Service Fees and Usage Fees.

19 Single family residential sewer service fees and usage fees shall apply if  
20 a sewer customer is served by city water and meets the single family  
21 service classification for water as set forth in Chapter 25 SFCC 1987. If  
22 not served by city water, single family residential sewer service fees and  
23 usage fees shall apply where the sewer connection serves only one unit\*  
24 for normal domestic sewage.

19                               0.9 x (C-D) x F x cf x L, for users whose discharge has been tested, and

1  $0.9 \times (M-D) \times F \times cf \times L$ , for users whose discharge has not been tested.

2 Where:

3 C = COD concentration in the user's discharge stream in milligrams per liter  
4 (mg/l)

5 D = Average domestic sewage COD concentration, established at 550  
6 milligrams per liter (mg/l).

7 F = Average water use in million gallons per month as shown in the water  
8 division records.

9 cf = 8.34. A factor to convert the units of milligrams to pounds per million  
10 gallons.

11 L = The mass based cost of providing air to remove the COD in wastewater.




