#### 1. CALL TO ORDER

Councilor Joseph Maestas, called the meeting of the Bicycle and Trails Advisory Committee to order at 5:39 p.m. at the City Council Chambers in Santa Fe, New Mexico. Roll call constitutes a quorum.

#### 3. APPROVAL OF AGENDA

It was decided to move the Thanksgiving Meal until after Item 9c.

**MOTION:** Mr. Rivera moved to approve the agenda as amended with a second from Mr. Newhall which passed by voice vote.

#### 4. APPROVAL OF MINUTES FROM OCTOBER 18, 2017

#### Corrections/Clarifications:

Ms. Grogan would like to clarify that it was agreed the Going for the Gold subcommittee would not continue once they hear about the approval.

Mr. Pacheco stated that he could not change the November 2018 meeting due to a scheduled City Council meeting.

**MOTION**: Ms. Grogan moved to approve the minutes of October 18, 2017 as amended or clarifies with a second from Ms. Robinson which was passed by voice vote.

#### 5. CITIZEN COMMUNICATION FROM THE FLOOR

Justin Greene (611 Campana Place) wanted to acknowledge the accident on West Alameda this week. Thanked NMDOT for coming tonight to discuss items like the Hyde Park Rd. facility, it needs improvement. Mr. Greene presented an idea for a Resolution he would like to see brought to Council (See Exhibit A).

#### 6. THANKSGIVING RECOGNITION

This item was moved towards the end of the meeting.

#### 7. COMMUNICATIONS FROM OTHER AGENCIES

#### a. City Trails Coordinator Report

Mr. Rogers reported his update on activities. (See Exhibit B) They have been working on walk with a doc. He tried to get the TPL but not successful. Mr. Rogers reported a new project with an eagle scout in Calle Lorca park is being done to place a wooden bridge. There has been work days on Camino Rael and Nina Otero. Also on La Tierra Trails, there are some good crew leaders.

Mr. Rogers stated there was one field trip to close out November. Thanks to the partners that have helped pay for the bus trips. Mr. Rogers helped with an event at the Food Depot. Mr. Rogers met with a citizen from Zocalo and Parks to discuss how to work on the trails. Some trails have disappeared because of erosion.

Mr. Rogers discussed the clearance needed for the dog connector trail. They are still waiting for assessments before the temperatures change. They have been working with the MPO to get data on the historical sites around that area.

Mr. Rogers also visited all abandoned rail beds. There is a rail triangle that is privately owned and is now proposed for development. It is historic and is important for drainage.

It is worth it for the City to acquire that land. Perhaps if there is money left over from La Tierra trails. Mr. Rogers stated the Gusto organization is planning to look at the alignment analysis for the Rio Grande Trail.

Mr. Rogers stated in the report, there are photos from the International Making Cities Livable conference.

Mr. Rogers discussed the e-mail included in the packet discussing Hospital Drive. Several bump outs have been placed there. He gave the resident his assessment. It is disappointing to see the same thing as Alta Vista happen again. Bicyclists have to weave in traffic. The projects on the master plan are for both bicyclists and drivers. He encouraged BTAC members to visit Hospital Drive to see the bump outs.

Mr. O'Leary asked about the dog park connector trail. What is happening with the archeological data. Mr. Rogers stated the State wants a new analysis with the alignment near 3 recorded sites. The City Review Committee gave them approval but you still need concurrence with the State Historical Preservation Office. The comments were that the sites need to be reexamined. He met with them in the field. They found what they proposed weren't impacting the sites. The contract archeologists are looking at the other 2 sites.

Mr. O'Leary asked if the property near Siringo Road has sold? Mr. Rogers stated yes it sold in August. Mr. O'Leary asked what the plans are to be developed. Mr. Rogers explained they are planning to keep the rail beds as trails. It remains to be seen what the development will be.

Mr. O'Leary agrees about Hospital Drive he doesn't want to see it become the normal. Why didn't they get bike lanes there? It happened fast, it seems like those roads and traffic calming methods aren't what they want for cyclists.

Mr. Pacheco wasn't involved, it speaks to what BTAC speaks about being in that loop for developments. The meetings Councilor Maestas proposed to have with Parks, and Public Works will be beneficial.

Ms. Grogan asked about the water line on the La Tierra trail. Mr. Pacheco stated the engineer Ms. Johansen is here and will report on it.

Mr. Newhall agrees on Hospital Drive, he rides regular basis, doesn't want to fight this with every street. It should be a policy for all, thinks that care needs to be used on the streets.

Councilor Maestas asked what the policy Streets has when these projects come up. Mr. Pacheco suggests staff or a member of BTAC be a member of the development review team, as a start.

Councilor Maestas suggests having Mr. Romero and Mr. Martinez on the next agenda to explain Hospital Drive. Then they can work with Legislative Services to write a Resolution to have BTAC involvement on projects.

Ms. Robinson discussed a presentation she attended regarding the work being done on Guadalupe Street. They looked at the maps. She asked what Mr. Rogers thought of the plans?

Mr. Rogers doesn't ride on that street, it is hostile. The project is part of a road safety audit, it is funded as a road diet. There are tight parts of the road. Bike Lanes are prioritized last. There is parking and there is no room for bike lanes. This project is a retrofit. There wasn't a lot of mention of bike lanes.

Ms. Robinson asked what the next step on that project is. Mr. Rogers states the next meeting will have alternative plans. Mr. Pacheco stated the schedule is to complete all plans by next year. The unique thing of the project they are creating a liaison committee, he suggests they have a subcommittee to have a presence there.

Mr. O'Leary spoke to the project manager and suggested having a BTAC member on the liaison committee. They were interested.

Councilor Maestas asked Mr. Pacheco to reach out to the Project Manager to work on appointing a BTAC member.

Councilor Maestas asked Mr. Rogers if he was interested in serving on a BTAC subcommittee. He stated he has served or can help in any technical manner.

Ms. Kristen Johansen, Engineer with the City Water Division and is the project manager on the Buckman Pipeline project. Ms. Johansen explained the pipeline project and how it runs from Camino de Los Montoyas and where it goes through in La Tierra trail.

Ms. Johansen explained the scope of work and timeframe on the project. The pipeline has been installed in the La Tierra trails. There will be construction traffic until March 2018. There are some restraint pipes and valves that need installation. They will be grading and seeding at the end of the project. That will be done in the spring. They have asked the contractors to place flagging or fencing around the open areas.

Councilor Maestas stated the main concern was the completion of the grade of the trail and it will it be replaced to the previous grade.

Ms. Johansen stated there will be tree trimming and yes it will returned to the grade, some gabions to prevent erosion.

Ms. Grogan asked what are they seeding and how will it be watered.

Ms. Johansen was not certain on the method they may spread it. It is the 7339 US Forest Service Mix. That will be done in late spring when the landscapers decide it is time. They will run through with watering trucks. They are under contract to make sure the seed takes before final payments they will inspect the site.

Ms. Grogan explained that is the concern of the Committee, asked if Ms. Johansen can report next spring.

Ms. Johansen stated they will provide a plan, she will forward to the BTAC Committee.

Mr. O'Leary asked what the width of the corridor is. Is there a way to stake it and get it to one lane while they work on it? Can they narrow it to help it heal?

Ms. Johansen states she will bring that up to them.

#### 8. INFORMATION, DISCUSSION & ACTION

#### a. New Mexico Bike Plan

Mr. Wade Patterson is the new bicycle and pedestrian coordinator for NMDOT. Mr. Aaron Sussman is working on the New Mexico Bike Plan. Mr. Sussman explained the goal is to look at the statewide NMDOT maintained roads, subset to smaller corridors where they want to invest to accommodate bicycle travel. (See Exhibit C)

Mr. Sussman explained the scope of the plan. The goal is to have a statewide program and they would like to identify tiers that connect the State and provide tourism improvement. They would like to identify the tiers and maps looking for recreational opportunities. There are high demands in cycling areas.

They want to link to the regional bicycle networks around the state. The will need to get public input. The idea is to identify the corridors. This would help NMDOT identify the networks for the roadways and infrastructure. Keeping in mind the resources available. Implementation of the project will be with the state NMDOT roadway redesign projects. This planning document becomes a resource when planning. This is not a project list. It is a systematic way to improve roadways over time. They are in the data collection phase now.

Mr. Sussman suggests people visit the website <a href="mailto:nmbikeplan@bhinc.com">nmbikeplan@bhinc.com</a> there is a questionnaire and an interactive online input map. Mr. Sussman explains the best way to address the Hyde Park Road issues. That way they can send comments and on the map there is a record.

Mr. Newhall discussed the issues with NMDOT and the way they leave the shoulder of the roads. The slope is dangerous for cyclists. He will go online and make the comments.

Councilor Maestas agrees the pavement depths and tapering off of the shoulder is dangerous. It was used as a cost saving effort. There is controlled access to facilities and they should parallel facilities to make sure there is a network redundant to the interstate. There are a lot of existing highway projects that need to make sure the facilities can accommodate the bicyclists.

Mr. O'Leary asked if this project was just for paved roads. As bike touring and off-road cycling become more popular they should look at it as a tourism issue.

Ms. Wellington agrees they should parallel the facilities. It is important to separate the grade paths that may require right of ways. It is important that NMDOT looks at it places like Colorado where they have some areas that have great parallel roads.

Councilor Maestas mentioned the tribal lands right of way issues. Is there a plan?

Mr. Patterson states they have worked with several tribal officials. If there are sensitive they are aware of those issues.

Councilor Maestas asked if on the schedule they can come back and update BTAC at the major milestones coming up. Mr. Patterson stated it was their plan was to report to the MPO.

Mr. Brent Bronwell (31 Agua Viviendo) asked about heat plans to incorporate into the plan.

Mr. Patterson explained there are several ways to get that data. Strava doesn't identify where they might like to ride.

Mr. Bronwell explained the Strava is a GPS and the heat data.

Mr. Sussman stated the interactive map will help them find the gaps.

Mr. Newhall explained that Adventure Cycles mapped out Route 66 through Santa Fe. He wants to make sure that route in on their maps.

Mr. Rivera agrees with the Strava issue, it tends to be used to ride for sport and not for commuting.

Mr. Rogers mentioned Guadalupe Street, next to DeVargas Mall is considered a state

frontage road. There is a designation.

Ms. Jackie Shane (1051 Chacomo Vista) discussed the map, the survey didn't have a lot of preferences and did not identify roads like St. Michaels. That street gets no maintenance and there is plenty of room for a bike lane but it is very dangerous.

Mr. Sussman explained how to use the interactive map. There will be a way to see the NMDOT roads and local roads. There is a copy of the public meeting presentation on the site.

Councilor Maestas explained the City and the State are working on the Road exchange on St. Michaels Drive. The state must first repair the road or resurface it.

Mr. Greene asked while designing the profiles if pedestrians will be included. Mr. Patterson stated the plan is focused on the bicycle plan only. The pedestrian plan is the next step.

Councilor Maestas asked if there is funding behind it? He hopes there is funding for the plan.

Mr. Patterson discussed than go out for extra money, this strategy is folding into activities that they are already engaged in.

Mr. Patterson suggested everyone fill out the questionnaires. There is an email address they can send to.

#### b. International Mountain Bike Association-IMBA Going for Gold

Mr. Bronwell presented the IMBA evaluation criteria (See Exhibit D). They will need to submit their application by July 2018.

Mr. Bronwell reviewed what he thought they would or could get in the scoring mechanism. Santa Fe isn't made for bike specific trails, there has to be technical trails. There is a \$1,000 for reevaluation that would go along with the application.

The Mountain Bike Club states they have the data to fill out the application it would be submitted by the City.

Ms. Robinson asked how does the club feel about sharing the trails, is there is a conflict between pedestrians and cyclists.

Mr. Bronwell states they review the reports with the US Forest Service on issues and work on them.

Ms. Robinson asked how they can build the features for these types of multi-use trails.

Mr. Bronwell explained the Club conducts trainings to train with pedestrians. He discussed the trails they are looking at.

Ms. Grogan asked about the trails in Pajarito. Mr. Bronwell explained it has to be within a 30-minute range, they will recognize a regional ride center but not a rating designation.

Ms. Grogan asked what kind of support is he requesting from the City? Financial, city staff or a subcommittee?

Mr. Bronwell states staff and perhaps a link to a website to trail heads and promote bike friendly hotels, etc. Perhaps with tourism.

Ms. Grogan asked that he put it together in a memo addressing what he would like help with.

Councilor Maestas asked what was included in 2014 with the first application.

Mr. Bronwell stated they managed to get it done with virtually no cost.

Councilor Maestas suggested staff draft another Resolution regarding the renewal. Mr. Bronwell stated there is one in Place.

Councilor Maestas states they can combine both and include the requirements and add the renewal. He would like this to be on the agenda for the next meeting.

Mr. O'Leary thanked Mr. Bronwell for working on this, on the scoring estimating out of all possible 40, if they cannot qualify for any what happens? Mr. Bronwell thinks they would get 30/40.

Mr. O'Leary states as they try to get more bike specific trails they don't have a lot of City owned land, but wonders if they can keep their eye on some opportunities?

Mr. Bronwell there are points for scheduled service for buses. There may be difficulties however, Glorieta may step in.

#### 9. BTAC SUBCOMMITTEE Reappointments

#### a. On Road Subcommittee

Councilor Maestas stated he will ask for volunteers for Chairs. Then the chairs can delegate to recruit member's, there can also be non BTAC members chosen.

Mr. Newhall will chair the On-Road Subcommittee.

#### b. Off Road Subcommittee

Mr. O'Leary will chair the Off-Road Subcommittee. Ms. Robinson asked about keeping La Tierra will fall under in the Off-Road subcommittee. It will continue under that subcommittee.

**MOTION:** Mr. Rivera moved to keep the La Tierra Trail subcommittee with the Off-Road Subcommittee with a second from Ms. Grogan which passed by voice vote.

#### c. Going for Gold

It had been discussed in the previous meeting to replace the Going for Gold Subcommittee with the Education subcommittee.

Ms. Wellington will chair the new Education subcommittee.

**MOTION:** Mr. Newhall moved to accept the Education subcommittee with a second from Ms. Robinson which passed by voice vote.

Councilor Maestas suggests this subcommittee work with the City PIO and the webmaster. They can be a liaison to the Education Subcommittee being a resource for Press Releases.

**MOTION:** Mr. Newhall moves to reconvene the meeting at 8:00 p.m. after the meal with a second from Ms. Grogan which passed by voice vote.

#### 10. STAFF COMMUNICATIONS

Mr. Pacheco will gather members that are interested in becoming part of the subcommittees.

#### 11. COMMITTEE COMMUNICATIONS

Mr. Rivera announced Chainbreakers Holiday event "Poselada" on December 17, 2017 at 5:00 p.m. on 5<sup>th</sup> Street. He will email a flyer. They will be fiving away 25 kids bikes and they serve posole.

A discussion was held concerning the crash with a cyclist. Ms. Shane discussed her efforts in informing officials about the area.

A discussion was held about the driver not being cited. A discussion was held about the transition to shoulder to no shoulder leading to dangerous situations.

#### 12. COMMUNICATIONS FROM THE CHAIR

Councilor Maestas discussed the Old Santa Fe Trail/ Alameda swap between the County and City.

Councilor Maestas asked Mr. Pacheco to look into standards for roundabouts and send to the Committee.

A discussion was held about the ribbon cutting ceremony for the Acequia Trail Tunnel.

Councilor Maestas would like to have the La Tierra Trails left over funding on the next agenda. He would like Mr. Pacheco to share any information with Mr. O'Leary with the Off-Road subcommittee.

#### 13. ADJOURNMENT

This Memorandum of Agreement, hereafter referred to as the Agreement, between the two above captioned parties: 1) Santa Fe Fat Tire Society, hereinafter referred to as SFFTS, and 2) City of Santa Fe, hereinafter referred to as "City", sets forth the parties' understanding concerning the creation of a new bike specific trail segment in the La Tierra Trails.

The primary purpose of this Agreement is to define the scope of work to be performed by SFFTS in creation of the new trail segment and define compensation from the City.

#### **GENERAL PROVISIONS:**

#### 1. Duration

This Agreement shall become effective on the date of execution of this Agreement is the date that the final signatory for either party signs and dates this Agreement. This Agreement is subject to performance of the terms as set forth in this Agreement. Activity on the project is scheduled to begin after April 1, 2015 and shall end upon completion of the new trail segment, unless terminated sooner by either or both the parties.

#### 2. Santa Fe Fat Tire Society Responsibilities. SFFTS will:

- a. Create an approximately 1 mile trail segment, South of, and roughly parallel to the existing trail between intersections 7-6-5.
- b. Subcontract with International Mountain Bicycling Association's (IMBA) Trail Solutions group to provide a professional trail builder for 10 days of consultation and construction on the new trail segment.
- c. Pay for all costs related to the IMBA Trail Solutions Subcontract in excess of the payment provided by the City. (Attachment A)
- d. Provide volunteers to assist the IMBA Trail Solutions professional builder in order to maximize the efficiency and productivity of the subcontractor.
- e. Provide volunteer labor to finish the trail construction, should the IMBA Trail Solutions professional builder be unable to complete the segment within their contracted time.
- f. The trail will be constructed as a one way bike specific trail containing a high density of specific features to enhance the rider experience such as berms, rollers, and appropriate turn radii.
- g. The trail shall be constructed within the reviewed and approved trail corridor and avoid the identified archeologically significant sites identified during the archeological survey. (Attachment B)

#### 3. City Obligations. The City will:

- a. Upon completion of the new trail segment, the City shall reimburse SFFTS, not to exceed \$10,000 inclusive of New Mexico Gross Receipts Taxes for expenses incurred during the construction.
- b. Provide SFFTS, its subcontractor and volunteers access to the construction site.

#### 4. Nondiscrimination and Sexual Harassment Compliance.

- a. No person with responsibilities in the operation of the project shall discriminate on the basis of race, religion, color, national origin, sex, age, disability, or political affiliation.
- b. SFFTS and its subcontractor(s) and volunteers shall comply with all federal and state laws regarding sexual harassment

#### 5. Delegation

The City will not delegate or assign any of the obligations or duties contained in this Agreement. However, SFFTS may delegate construction to its subcontractor, IMBA Trail Solutions (Attachment A)

#### 6. Amendments

This Memorandum of Agreement may be amended at any time by an agreement in writing executed by authorized representatives of the City and SFFTS.

#### 7. Severability

If any provision of this Agreement is construed as illegal or invalid, this will not affect the legality or validity of any of the other provisions contained in this Agreement. The illegal or invalid provision will be deemed stricken and deleted from the Agreement to the same extent and effect as if it never existed, but all other provisions will continue in effect.

#### 8. Appropriations

The terms of this Agreement are contingent upon sufficient appropriations and authorization being made by the City for the performance of this Agreement. If sufficient appropriations and authorization are not made by the City, this Agreement shall terminate upon written notice being given by the City to SFFTS, prior to estimated start date of the project. The City's decision as to whether sufficient appropriations are available shall be accepted by the SFFTS and shall be final.

#### 9. Confidentiality

Any confidential information provided to or developed by SFFTS in the performance of this Agreement shall be kept confidential and shall not be made available to any individual or organization by the SFFTS without prior written approval of the City.

#### 10. Conflict of Interest

SFFTS warrants that it presently has no interest and shall not acquire any interest, direct or indirect, which would conflict in any manner or degree with the performance of services required

under this Agreement. SFFTS further agrees that in the performance of this Agreement no persons having any such interests shall be employed.

#### 11. Indemnification

SFFTS shall indemnify, hold harmless and defend the City from all losses, damages, claims or judgments, including payment of all attorneys' fees and costs on account of any suit, judgment, execution, claim, action or demand whatsoever arising from SFFTS performance under this Agreement as well as the performance of SFFTS's volunteers, agents, representatives and subcontractors.

#### 12. New Mexico Tort Claims Act

Any liability incurred by the City of Santa Fe in connection with this Agreement is subject to the immunities and limitations of the New Mexico Tort Claims Act, Section 41-4-1, et seq. NMSA 1978, as amended. The City and its "public employees" as defined in the New Mexico Tort Claims Act, do not waive sovereign immunity, do not waive any defense and do not waive any limitation of liability pursuant to law. No provision in this Agreement modifies or waives any provision of the New Mexico Tort Claims Act.

#### 13. Third Party Beneficiaries

By entering into this Agreement, the parties do not intend to create any right, title or interest in or for the benefit of any person other than the City and SFFTS. No person shall claim any right, title or interest under this Agreement or seek to enforce this Agreement as a third party beneficiary of this Agreement.

#### 14. Applicable Law; Choice of Law; Venue

SFFTS shall abide by all applicable federal and state laws and regulations, and all ordinances, rules and regulations of the City of Santa Fe. In any action, suit or legal dispute arising from this Agreement, the Contractor agrees that the laws of the State of New Mexico shall govern. The parties agree that any action or suit arising from this Agreement shall be commenced in a federal or state court of competent jurisdiction in New Mexico. Any action or suit commenced in the courts of the State of New Mexico shall be brought in the First Judicial District Court.

#### 15. Scope of Agreement

This Agreement incorporates all the agreements, covenants, and understandings between the parties hereto concerning the services to be performed hereunder, and all such agreements, covenants and understandings have been merged into this Agreement. This agreement expresses the entire Agreement and understanding between the parties with respect to said services. No prior agreement or understanding, verbal or otherwise, of the parties or their agents shall be valid or enforceable unless embodied in this Agreement.

Dear Mr. Pacheco:

Per your request I am sending a summary of the work completed by members of the Santa Fe Fat Tire Society (SFFTS) to create a new city trail in La Tierra Trails that is commonly referred to as the "Flow Trail." In my capacity as "City Trails Volunteer Coordinator," it was a pleasure to work with SFFTS leadership; SFFTS's contractors including Joey Klein of IMBA Trail Solutions and Stephen Post of Zia Archaeology; a wide variety of trail volunteers including members of SFFTS, the Trails Alliance of Santa Fe, and various other individuals who contributed to the project; the City's Bicycle and Trails Advisory Committee (BTAC) and Archaeological Review Committee (ARC); and various City staff in Trails Engineering, Parks and Recreation, and archaeological review, to ensure that the project proceeded in line with the City's expectations and contractual obligations between the City and SFFTS.

I am pleased to report that the final product is a completed trail per specifications in the Memorandum of Agreement (MOA) between the City of Santa Fe and SFFTS (identified by the City as Item #15-0209). The completed Flow Trail is a bicycle-specific, one-way "technical" trail measuring just over one mile in length, as described in the MOA. Trail work stayed within the corridor that was surveyed by Mr. Post and approved by the ARC for trail construction. This work was completed without adversely impacting three archaeological sites identified by Mr. Post and the ARC as requiring protection. Work on the trail was completed by SFFTS on May 3, 2015, including clean-up of all extraneous traces of construction work on the Flow Trail, obliteration of tracks created through the authorized use of motor vehicles and other mechanized equipment along adjacent trails, and the removal of posts and fences that had been put in place to protect the three archaeological sites identified as requiring protection.

The completed Flow Trail is nearly exactly as depicted on the La Tierra Trails portion of the City's latest Foothill Trails Map. However, in the process of designing and planning the Flow Trail, needs were identified to adjust the originally identified and scoped alignment in order to (1) have the trail finish at a pre-existing trail junction (#13) and (2) facilitate a mid-point connection to the Flow Trail from La Tierra Trails' Junction 6. These new proposed alignments were reviewed by Mr. Post, who found no new sites requiring protection, and subsequent trail work on these adjusted alignments was approved by the City ARC. The connection to Junction 13 was completed during the week of April 20, 2015, to finish the new 1.03-mile alignment. The short mid-point connection, which was not identified nor required under the MOA, has not been completed but remains approved for construction, and may occur this Summer

through volunteer labor under the auspices of SFFTS and myself. SFFTS and other volunteers will continue to maintain the Flow Trail though the course of 2015 and into the future in order to optimize banked turns and rises that are essential elements of the Flow Trail.

The work on the Flow Trail and the final product are documented on the Santa Fe Conservation Trust (SFCT) web site under the title "Flow Trail Construction, La Tierra Trails, Apr. 9 – May 3, 2015" at <a href="http://www.sfct.org/trails/sfct-trail-events-in-2015/flow-trail-construction-la-tierra-trails-apr-9-may-3-2015">http://www.sfct.org/trails/sfct-trail-events-in-2015/flow-trail-construction-la-tierra-trails-apr-9-may-3-2015</a>. As described there, Trails Engineering Section head Leroy Pacheco, City Archaeologist Lisa Roach, SFCT Executive Director Charlie O'Leary, and myself visited the completed trail on Friday, May 8, and all found the Flow Trail to be quite satisfactory with respect to the City's expectations and requirements. A celebration of the completed Flow Trail took place on Wed., May 13, including a ribbon-cutting by City Councilor Patti Bushee, Chair of BTAC (see Figure 1 below), and a volunteer recognition event, both of which took place at the top of the Flow Trail, just west of La Tierra Trails' Junction 7.

SFFTS calculates that the construction of the Flow Trail required nearly 1,000 hours of volunteer labor by more than 60 individuals in addition to the paid professional assistance by Mr. Klein of IMBA, Mr. Post of Zia Archaeology, and myself. The Flow Trail is now being enjoyed by local bicyclists as well as visitors to the Santa Fe area, and will continue to serve as an important resource to support our local quality of life as well as our outdoors-based economy. I am happy to conclude that SFFTS has fulfilled its obligations to the City specified in the MOA identified as Item #15-0209.

# La Tierra Trails System – Connector Trail from Frank Ortiz Dog Park to Camino de los Montoya's Trail

- The project is listed in the August 2012 updated Trails Master Plan Project List with a cost range estimated at \$300,000.00
- In 2009 the city council amended the General Land Use Plan to include amendments to parcels in the 542 acres in the Northwest Quadrant south of NM 599.
- The Santa Fe Public Schools owns approximately 7% of the property in the Northwest Quadrant, and is a stakeholder in development of city infrastructure in the area.
- In 2015 the city made application to the New Mexico DOT for consideration of a federal grant for this connector trail with a proposed cost to design and construct of \$250,000.00. Application included a city council approved resolution to indicate political support for the trail. The application was not selected for grant of funds.
- The proposed connector trail would be approximately 0.65 miles in length, and typically 10-ft wide with a firm and unyielding surface.
- Project stakeholder's include:
  - 1. Surrounding Neighborhoods (Casa Solana, Santa Fe Estates, etc.)
  - 2. Diverse Trail users (hikers, bicyclists, equestrians, dog-walkers,)
  - 3. Americans with Disabilities
  - 4. Archeological interests (Native American Tribes)
  - 5. The Santa Fe Public Schools
- City agents: Public Works (Engineering, Traffic, Streets and Drainage), Historic Preservation, Mayor's Committee on Disability, Land Use, Parks & Recreation
- There are drainage and terrain considerations and challenges to be considered and overcome in the proposed trail corridor.
- There are traffic design considerations in crossing users at Camino de las Crucitas and Camino de los Montoyas.



# G. DISCUSSION

# 1. Clarification of Action by the BTAC on August 26, 2008 Regarding Museum Hill Trails

Mr. Leroy Pacheco said Mr. Harrington brought up this little discrepancy between what the August 26, 2008 minutes said and his understanding of what Mr. Harrington and Mr. Longworth and Mr. Siqueiros discussed out in the field. The minutes, on page 33, said Ms. Mastrangelo had clarified that her motion was that the trail would have a natural surface. The motion passed by unanimous vote.

His understanding of the discussion was that they were using the old Camino Lejo road alignment from Old Pecos Trail to Camino Corrales - the old abandoned road bed and cross Camino Corrales and use the existing Lejo to get to Old Santa Fe Trail

- Mr. Bordegaray said on the map it was the red trail and what they did was to split the two trails (east side of Corrales and west side of Corrales). There were two trails on each side.
  - Mr. Harrington said the Committee did vote for the off-road trails.
- Mr. Herdman clarified that this was not an action item but for discussion and they already had a public hearing.
- Mr. Harrington thought the whole committee felt they were approving a dirt trail and it came back as a paved project. He was adamantly against a paved trail. Paving the green alignment would be very dangerous.
- Mr. Leroy Pacheco suggested it would be helpful just to have the Committee restate what the motion was. He explained that part of his confusion was that originally he was looking at a different exhibit with the green, red, and yellow alignments.
  - Mr. Bordegaray said he had the original and it coincided with the exhibit.

- Mr. Leroy Pacheco felt it would help if they had the same map.
- Mr. Harrington asked if it would be better to make a motion on it.
- Mr. Herdman said they needed to be careful because this was not to take any action.
- Mr. Franklin said it looked pretty clear to him. It looked like Mr. Harrington said he would move a nobuild on the yellow trail. Mr. Harrington agreed. Mr. Bordegaray said he would second the motion with a friendly amendment that the intersection of Camino Corrales and Camino Lejo be striped with crosswalks. Chair Bushee said that would require engineers to weigh in and go through departmental approvals. Mr. Bordegaray then changed his amendment requesting sharrows at intervals to be determined on both Camino Lejo and Camino Corrales and that passed by unanimous voice vote.
  - Mr. Bordegaray said that was the whole section from Old Pecos Trail to Old Santa Fe Trail.
- Mr. Franklin quoted further that Mr. Harrington said they would also no build the blue trail. Mr. Bordegaray seconded that motion. Ms. Mastrangelo said that was not okay. But there was confusion about which trail they were talking about. Mr. Harrington was not saying no-build for the green trail; he was talking about the blue trail. And then evidently it passed.
- Mr. Leroy Pacheco clarified that they were doing the red trail between Old Pecos Trail and Camino Corrales and the green trail of natural surface between Camino Corrales and Old Santa Fe Trail.
- Mr. Bordegaray said the only thing they could be certain of was that they okayed the green trail as a natural surface. The red trail had all kinds of issue about the botanical garden providing adequate funding for this. That was an item that the BTAC was not able to fund at this time.
- Mr. Harrington said there were 3 issues He was clear about on the red trail. One was that there was supposed to be a cooperation of the Botanical Garden and asked if that meant the City was only going to get involved in it as and when the Botanical Garden moved on it. The second thing that was unclear was that she moved to build it with an undercrossing and Chair Bushee reiterated that in the minutes. So it was unclear if it was contingent on having an under-crossing which he considered too expensive and impractical. The third thing that was unclear was that the motion said at one point a pedestrian trail but at another point it was pedestrian and bicycle so it was unclear what kind of trail was to be put in there. So the red trail was a mess.
- Mr. Leroy Pacheco said most of the Botanical Garden was east of Corrales so the development would be up the stream; not between Old Pecos Trail and Camino Corrales but between Old Pecos Trail and Old Santa Fe Trail.

His understanding was that the Botanical Garden did not have capital money to build the trail but wanted to have influence in the trail design. He thought the Botanical Garden issue would be more pertinent for the green trail on that side of the street.

- Mr. Harrington said Ms. Wellington's motion on the red trail was to collaborate with the Botanical Garden.
- Mr. Bordegaray agreed that funding was ambiguous and they wanted a commitment from the City that the City would collaborate closely with them at some point. He had asked when they would expect to have the funding available for it and they said they were not raising funds for it but were hoping to do that in the future. So the red trail was just "some day."
  - Mr. Leroy Pacheco countered that the red trail was not where the Botanical Garden was located.
  - Mr. Bordegaray said the tie in was the key; the tie in at Corrales road.
- Mr. Harrington felt they could not avoid redoing that action on the red trail because it was not clear at all.
- Mr. Herdman was not sure it was on the agenda for that purpose. What he saw in the minutes was a motion to collaborate with the Botanical Garden on the red trail. Chair Bushee had summarized that the motion was a collaboration with Botanical Gardens for a rustic trail with public access and the motion passed. It seemed to him that it was clear what passed. But it might not be clear what to do with it.

He asked if BTAC needed to revisit it with a report back from staff on collaboration or something else.

- Mr. Harrington said an issue with it was the under-crossing.
- Mr. Bordegaray suggested since there were these separate issues, he wondered if they could agree that what they had captured on yellow, blue and green was what they agreed upon and that the discrepancy was on the red trail and they asked staff to bring that back for a public hearing.
- Ms. Wellington said there was substantial discussion about the financing and on page 31 there was a statement about the Botanical Garden having a designer who could design it and the City would take on the installation of it since the City had the deeper pockets.
  - Mr. Harrington agreed and that was the red trail they were talking about.
- Ms. Wellington said the key word on page 33 was that the public access would go under Camino Corrales with an emphasis on "under." And that passed finally by a vote of 4 to 2.
- Mr. Leroy Pacheco said he met with Ms. Millborn shortly after that meeting to recap her understanding, etc. Her assumption was that we would not be rebuilding any crossing under Camino Corrales. He said it would behoove the BTAC members to all go under it (the under-crossing). He felt she would be fine with having a pedestrian access point from the red trail into the Botanical Garden a trail system under the road. He did not think she understood she had committed to the design of the red trail but just with the

integration with the paths in the Botanical Garden. She didn't think bicycles could use it.

Mr. Pacheco said it was clear from this discussion that the green trail was to have a natural surface.

Mr. Herdman suggested they put on the next agenda an item on the status of collaboration with the Botanical Garden for the Red Frail and ask Ms. Millborn to come to the meeting. It could be part of the continuing discussion on their involvement with the red trail.

Mr. Pacheco concluded that the green trail between Camino Corrales and Old Santa Fe Trail was to be a natural surface off road and asked if it was pedestrian only or included bicycles. He pointed out that a bicycle trail off road would have driveways and parking lots.

Mr. Harrington felt anything that would encourage bicycle use there would be a bad idea because of all the driveways and the slope would make it quite fast. He had voted for it because he thought it would be dirt that, in itself, would keep most bicycles off of it. Even a bicycle lane on the road was a bad idea.

Mr. Leroy Pacheco concluded that they would intentionally keep the bicycles on the road. He was not sure the City could build a wildemess trail that was unpaved within the City from an ADA perspective.

Mr. Harrington repeated that the BTAC motion was to approve the green trail with a natural surface.

Mr. Leroy Pacheco pointed out that it would come back to the BTAC as it went through the design process.

Mr. Herdman cautioned that clarification was what was on the agenda and wanted to make sure they were not interpreting or amending or changing that action. That was not on our agenda. It appeared to be clear regarding the yellow, blue and green alignments and if staff felt they could not do green with a natural surface, it should be brought back for reconsideration. He asked Mr. Pacheco if there was still uncertainty apart from what they could not do.

Mr. Leroy Pacheco said it had been very edifying and, based on the exhibit, had cleared it up for him. The Committee could still invite the botanical gardens to come back to help interpret before a design contract was done.

Mr. Herdman asked if that motion had included that the Botanical Garden could come back to address collaboration with the BTAC or if it directed staff to go collaborate.

Ms. Wellington said she understood staff would collaborate with them and then staff would take care of the design with a landscape architect. She also understood the only part of the red trail that the Botanical Garden would be involved with was that underpass as the underpass would come up into the garden.

Mr. Herdman asked if it would it make sense to have a report on the collaborative work. The Committee members agreed.

- Mr. Herdman said that could be on the next agenda.
- Mr. Franklin said if there was an update on the green trail that could be included at the same time.

# 2. Review of the BTAC 2004-2006 Funding Priorities Map

- Mr. Siqueiros reported that there were only two trails under construction: the Richards Avenue Trail (#6) that the Board voted to no build around it, and the second was #12 that was just south of Baca Street behind Tecolote. Those were the only two out of the 13.
- Mr. Bordegaray asked him to point out where the proposed crossing of St. Francis at Zia was on the map.
  - Mr. Siqueiros said it was shown in brown.
  - Mr. Bordegaray concluded it did not exist on this map.
  - Mr. Siqueiros was not sure that an underpass was even being considered back then in 2006.
- Mr. Bordegaray pointed out that several BTAC members had not participated in consideration of this map and they were basing all their work on this map.
- Mr. Siqueiros said this map was the map that was approved in 2004 and it wasn't changed to reflect what BTAC had changed since then.
- Mr. Leroy Pacheco noted that he began a year ago in 2008 and was not involved in any of these planning processes. As his working tool for the BTAC in developing the 2009 bikeways map that showed a dash line crossing... Ms. Robinson and Ms. Mastrangelo were heavily involved with the MPO staff who was the map developer. In trying to determine which BTAC priorities should be shown on the map to be built by next summer, there were 6-7 BTAC projects on the map that was showing what trails and streets bicyclists should be using. The intention was to eliminate the unbuilt stuff and keep it real so that in 2010, those six or seven dashed lines would be built. So that had been his priority to be working on.
  - Mr. Herdman said he wasn't aware of that.
  - Mr. Bordegaray felt using the 2004-2006 map might be inadequate in today's discussion.
  - Mr. Sigueiros clarified that this map was the unaltered version of what BTAC acted on.
- Mr. Herdman thought they should superimpose the 2009 bikeways map with this 2004-2006 map to provide the big picture vision.
