

From my perspective, the approach and hostility you're showing weakens any argument you may have and tells me, at least, that you have some type of vendetta or alternate agenda going on.


I'm actually impressed that he talke things out with his opponent and settled the issue so amicably. I would think that as a mediator, you'd appreciate that.
