WHEREAS, the municipal ballot question concerns amendments to the Santa Fe Municipal Charter (Charter) that would, if approved, repeal the election date and terms of office specified by the Charter so that the City can align its election date and terms of office with the New Mexico Local Election Act; and

WHEREAS, the form and exact language of the municipal question, hereinafter referred to as the "Local Government Ballot Question," is set forth on the attached City Resolution No. 2018-55, which the City adopted on August 8, 2018; and

WHEREAS, the Board of County Commissioners of Santa Fe County (Board) may authorize the Local Government Ballot Question to appear on the 2018 General Election Ballot.

NOW, THEREFORE, BE IT RESOLVED that the Board hereby authorizes the Local Government Ballot Question, as set forth in City Resolution No. 2018-55, to appear on the 2018 General Election Ballot

17	BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF SANTA FE:
18	Section 1. DATE AND PURPOSE OF ELECTION. Pursuant to NMSA 1978,
19	Section 1-12-71 and Section 1-22-10.1 of the Local Election Act, a municipal ballot question shall be
20	placed on the November 6, 2018 Santa Fe County General Election Ballot, for the purpose of voting
21	for or against amending provisions of the Santa Fe Municipal Charter (hereinafter "Charter"). The
22	amendments would remove language specifying election dates and the date on which officials take
23	office. The following amendments would be made to the Charter if the voters approve the ballot
24	question in Section 2, below:

ARTICLE IV. ELECTIONS

2		4.01 Elections.
3		A. Regular elections. Regular city elections shall be held [on the first Tuesday
4		in March of each even numbered year] as provided by law.
5	(2)	ARTICLE V. THE MAYOR
6		Charter Section 5.03
7		5.03. Term of office.
8		The mayor shall be elected for a term of four years[, which shall begin on the sixth
9		day after the election-and-continue until a successor has been duly elected and has
10		taken office].
11	(3)	ARTICLE VI. THE GOVERNING BODY

13		Councilors shall be elected for a term of four years[, which shall begin on the sixth
14		day after the election and continue until a successor has been duly elected and has
15		taken office]. The terms of office of the two councilors from each district shall be
16		staggered so that one councilor shall be elected from each district at each regular
17		municipal election.
18	(4)	ARTICLE VII. MUNICIPAL COURT
19		7.04. Term of office.
20		The municipal judge shall be elected for a four-year term[, which shall begin on the
21		sixth day after the election and continue until a successor has been duly elected and
22		has taken office].
23	(5)	ARTICLE XI. GENERAL PROVISIONS
24		11.01. Transition.
25		A. Elected officials. City officials who are incumbent on the effective date of

1	this Charter shall serve out their elected terms unless recalled under the provisions of
2	this Charter.
3	B. Appointed officials. All incumbent appointed officials and commissioners
4	shall serve out their appointed terms unless removed in accordance with city
5	ordinances, resolutions or state law.
6	C. City officials shall serve their elected terms pursuant to this Charter unless
7	the ending date of their term is changed pursuant to the Local Election Act.
8	Section 2. MUNICIPAL QUESTION TO BE SUBMITTED. The following
9	municipal question shall be submitted to the qualified electors of the city of Santa Fe:
10	MUNICIPAL QUESTION
11	CITY OF SANTA FE MUNICIPAL CHARTER AMENDMENTS
12	Shall the Santa Fe Municipal Charter be amended to allow the City to enact by ordinance its election date and the date on which officials take office as provided in the
13	Local Election Act?
14	This change would amend Section 4.01(A) Election Date; Section 5.03 Mayor Term; Section 6.05 Councilor Term; Section 7.04 Municipal Judge Term; and Section 11.01 Transition.
