### Alcohol at Christus Gala

**SUMMARY:** The proposed bill amends Subsection 23-6.2 SFCC 1987 to permit the sale and consumption of alcohol in an area of the Plaza along the north curbline of Palace Avenue, running in front of the Palace of the Governors, between Washington Street and Lincoln Avenue for the Christus St. Vincent 150<sup>th</sup> Anniversary Gala on September 19, 2015.

10 AN ORDINANCE

11 AMENDING SUBSECTION 23-6.2 SFCC 1987 TO PERMIT THE SALE AND  
12 CONSUMPTION OF ALCOHOL IN AN AREA OF THE PLAZA ALONG THE NORTH  
13 CURBLINE OF PALACE AVENUE, RUNNING IN FRONT OF THE PALACE OF THE  
14 GOVERNORS, BETWEEN WASHINGTON STREET AND LINCOLN AVENUE FOR  
15 THE CHRISTUS ST. VINCENT 150<sup>TH</sup> ANNIVERSARY GALA ON SEPTEMBER 19,  
16 2015.

17  
18 BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF SANTA FE:

19 Section 1. Subsection 23-6.2 SFCC 1987 (being Ord. #2012-20, as amended) is  
20 amended to read:

21 23-6.2 Permitted Locations for the Sale and Consumption of Alcohol on  
22 City Property.

23 The sale or consumption of alcoholic beverages is permitted at the following locations on  
24 city property:

25 A. The Santa Fe community convention center and adjacent outdoor spaces under

1 the center's control;

2 B. That area of the Santa Fe municipal airport main terminal building and adjacent  
3 areas operated as a restaurant; and

4 C. The Marty Sanchez Links de Santa Fe (golf course).

5 D. The area of the Forty Marcy ballpark designated for concessions and seating shall  
6 be used for the sale and consumption of only beer and only at professional baseball games.

7 (1) A special dispenser permit shall be used to dispense alcohol. The alcohol  
8 dispenser shall comply with all state and local laws and regulations for dispensing  
9 alcohol pursuant to the special dispenser permit.

10 (a) Persons desiring to consume beer shall be required to wear a  
11 wristband that restricts consumption to a maximum of three (3) twelve (12)  
12 ounce beers during the course of a professional baseball game.

13 (i) The wristband shall be nontransferable and shall be  
14 issued to verify age and to indicate the number of alcoholic beverages  
15 purchased.

16 (ii) The purchase of alcoholic beverages shall be limited to  
17 one (1) purchase per person at one (1) time.

18 (iii) Twelve (12) ounce beverage containers shall be used for  
19 beer.

20 (iv) Alcoholic beverage containers shall be distinguishable  
21 from nonalcoholic beverage containers.

22 (b) The sale of beer shall terminate at the end of sixth inning of the  
23 professional baseball game.

24 (c) In addition to alcoholic beverages, food and non-alcoholic  
25 beverage drinks shall be sold. Water shall be provided at no cost.

1 (d) A manager of the alcohol vendor shall be present at all times in  
2 the concession area. A photograph of the manager and his or her name shall be  
3 posted at the point of sale of alcoholic beverages. At all times, the manager shall  
4 wear a nametag that identifies him or her as the manager.

5 (e) Alcohol servers shall not drink alcohol during baseball games.

6 (f) The vendor shall place signs in the concession area and outside  
7 the concession area that indicate the illegality of selling, serving and providing  
8 alcohol to minors and intoxicated persons.

9 (2) Any professional baseball league games subject to this section, shall not  
10 take precedence over the scheduling of local youth baseball leagues using Fort Marcy  
11 Ballpark.

12 E. An area of the Railyard park, designated as a beer garden and permitted in  
13 accordance with all city and state requirements, may be used for the sale and consumption of beer  
14 and wine, during the bike and brew festival if a valid permit is acquired from the Santa Fe  
15 railyard community corporation. This section shall be reviewed by the governing body within  
16 one (1) year from the date of adoption.

17 F. On September 19, 2015, during the Christus St. Vincent 150<sup>th</sup> anniversary gala;  
18 an area of the Plaza along the north curbline of Palace Avenue, running in front of the Palace of  
19 the Governors, between Washington Street and Lincoln Avenue. The event sponsor shall comply  
20 with the provisions of Section 23-6.3 SFCC 1987, except that the designated drinking area, shall  
21 extend no more than fifteen (15) feet into Palace Avenue, covered by a tent; and the mandatory  
22 buffer shall be a minimum of three (3) feet high and twenty (20) feet wide to maintain an  
23 emergency fire lane. Only security personnel will be permitted within the twenty (20) foot  
24 buffer. At all times, the event sponsor shall comply with the requirements of the 2009  
25 International Fire Code.


1           [F]G. Buildings owned by another party located on land owned by the city.

2           [G]H. On land or buildings owned by the city for which the city has entered into a lease  
3 with another party for six (6) months or more except for the Railyard park, Plaza and Alameda (as  
4 defined in the Deed of Conservation Easement dated October 1, 2004) where alcohol is  
5 prohibited, unless specifically permitted under Subsection 23-6.2 SFCC 1987.

6           [H]I. In or on railroad cars located on railroad tracks except as prohibited by state or  
7 federal law.

8           All other applicable approvals required by state or city laws and regulations shall be  
9 obtained prior to the sale or consumption of alcoholic beverages on the property described in this  
10 subsection 23-6.2.

16 **Body August 12, 2015.**

17           *“An area of Fort Marcy ballpark, designated as a beer, wine and margarita*  
18 *garden, and permitted in accordance with all city and state requirements, may be*  
19 *used for the sale and consumption of beer and wine during the fiesta council*  
20 *mariachi extravaganza concert, if a valid permit is acquired from the city of*  
21 *Santa Fe. The event sponsor shall comply with the requirements of 23-6.3 SFCC*  
22 *1987, except that alcohol content may exceed the allowable limit to permit the*  
23 *sale of margaritas. This section shall be reviewed by the governing body within*  
24 *one (1) year from the date of adoption.”*
