





ITEM & ISSUE

Request from Cynthia Canyon for a waiver of the 300 foot location restriction and approval to allow the dispensing/consumption of beer and spirits at the former First State Bank Building, 100 N. Guadalupe, which is within 300 feet of Our Lady of Guadalupe Catholic Church, 417 Agua Fria Street.

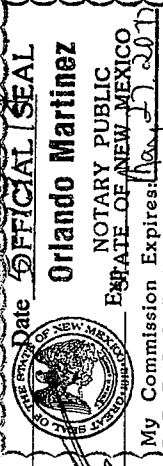

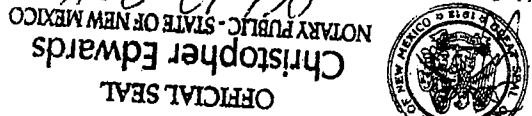

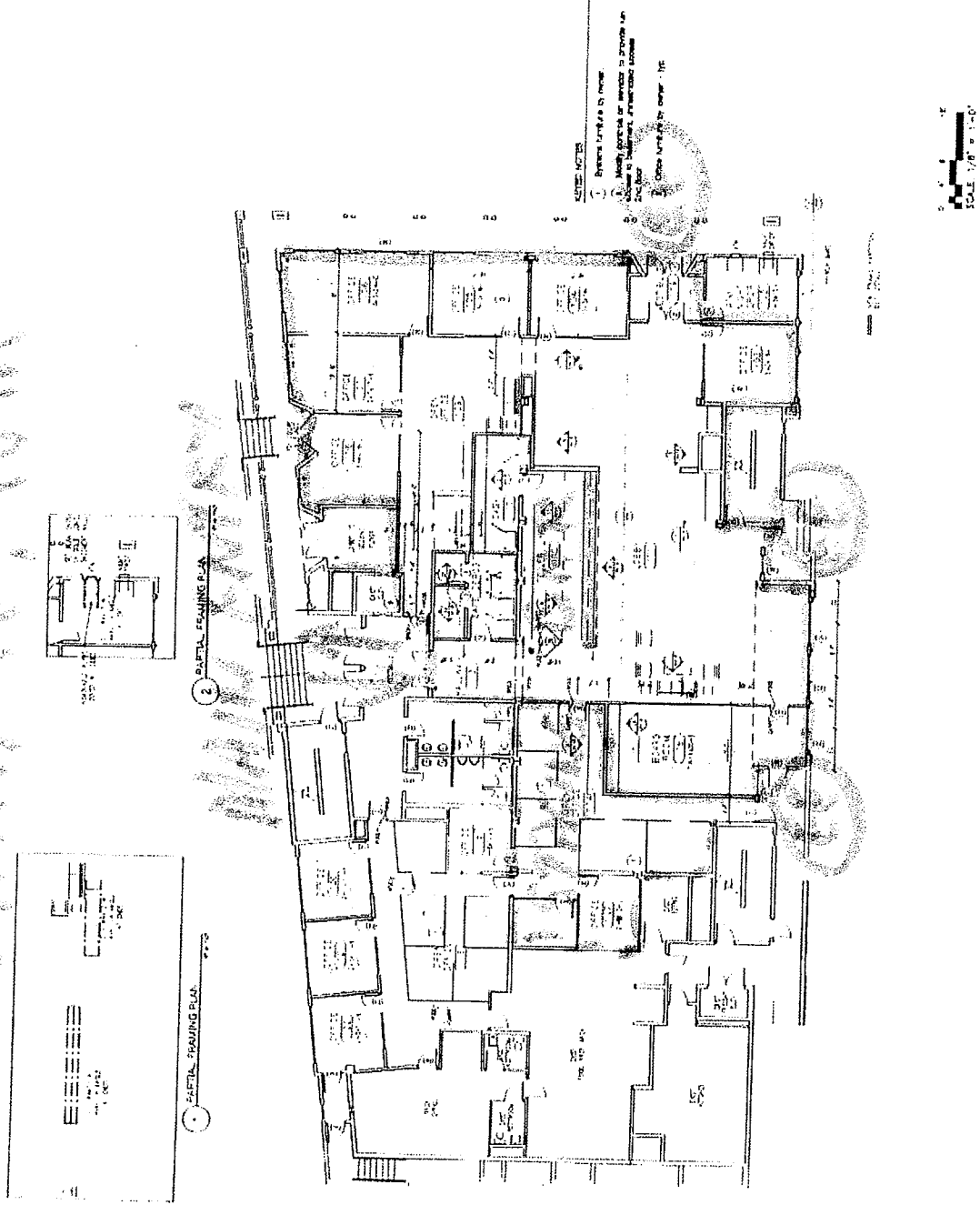
