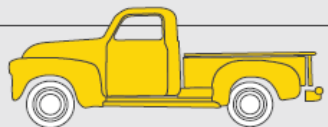
New rules make it easy to be an entrepreneur in Santa Fe. Its now legal to sell things from automobiles, trailers and pedal-powered vehicles in any legal parking space in the city for up to 3 hours.*

*special rules apply around the plaza

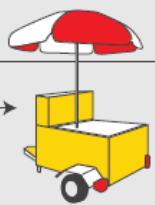
Where can you park? | ¿Dónde se puede aparcar?

Any legal public parking space on street or in public lots, anywhere but the Plaza Periphery
 Cualquier espacio de aparcamiento público legal en la calle o en lotes públicos o en cualquier lugar, excepto la periferia de la plaza

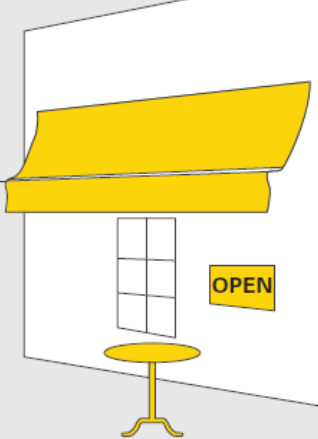
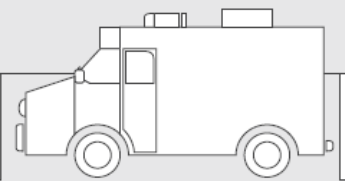
Any private parking space with landowner's written permission
 Cualquier espacio de estacionamiento privado con el permiso escrito del propietario



Trailers need to be left alone in a parking space and the vehicle in another legal spot, if they don't fit in one legal space
 Los trailers necesitan ser dejado solo en un espacio de estacionamiento y el vehículo en otro lugar legal



Food sales can't be 150ft of a street level food establishment entrance when they are open, unless the owner approves in writing
 Las ventas de alimentos no pueden estar dentro de 150 pies de la entrada de un establecimiento de comida cuando esto está abierto, a menos que el propietario del establecimiento aprueba por escrito

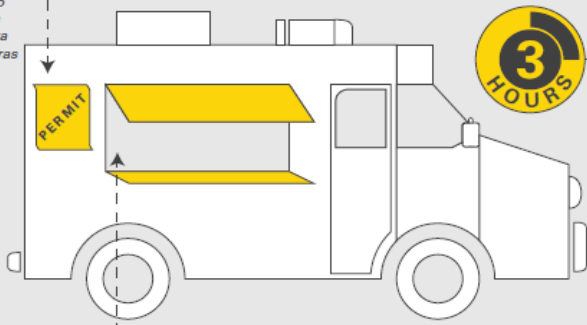

Must fit in one legal parking space

Rules for Operation Reglas para la Operación

Must display permit on outside of vehicle
 Debe mostrar el permiso en el exterior del vehículo

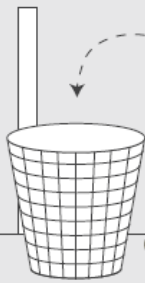
Must pay meter, but you can stay three hours, even if it's a two-hour meter
 Debe pagar metro, pero puede permanecer tres horas, incluso si se trata de un metro de dos horas



300 ft

Cannot stay in one place longer than 3 hours. Must move 300 ft after 3 hours.
 No se puede permanecer en un lugar por más de 3 horas. Debe mover 300 pies después de 3 horas.

Must pick up trash related to your business
 Debe recoger toda la basura relacionada con su empresa

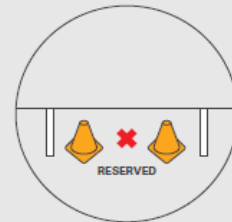

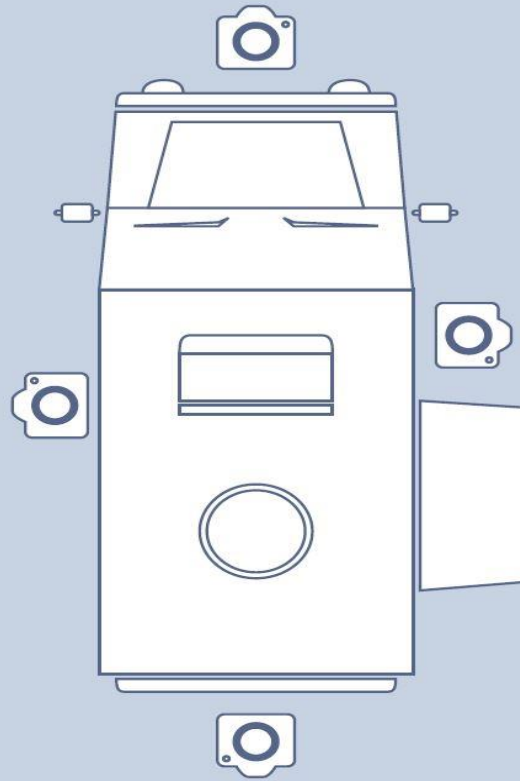
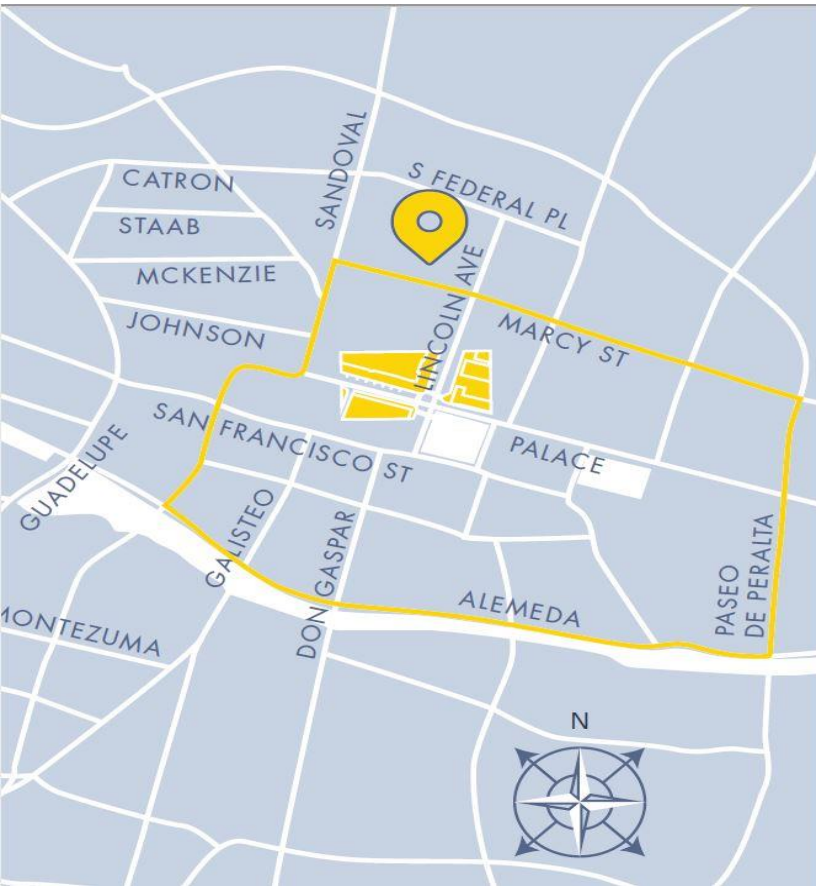

To get a Vehicle Vending license you need to register with the City of Santa Fe.

for your vehicle (including trailers)
