Incorporation of Wholesale Sewer Rates specific to Santa Fe County to serve Properties

Located Outside the Presumptive City Limits in Accordance with the Settlement Agreement

and Mutual Release of Claims# 08-0832

ITEM

Request approval of an ordinance relating to sewer rates for properties located outside the city limits; amending subsection 22-6.2 SFCC 1987 to establish that the Santa Fe County Housing Assistance Ordinance shall have jurisdiction over properties outside the city limits; and amending Rule 8 A. of Exhibit A of Chapter 22 SFCC 1987, City of Santa Fe Sanitary Sewer Rate, Fee and Penalty Schedule, to establish customer wholesale rates for properties located outside the city limits that are connected to the city sewer system.

SUMMARY

The reason for incorporating wholesale rates into the rate structure is to provide Santa Fe County the ability to establish a Utility that incorporates wastewater services to serve properties located outside the Presumptive City Limits which the City has approved or may approve sewer service in accordance with SETTLEMENT AGREEMENT AND MUTUAL RELEASE OF CLAIMS#08-0832. These wholesale rates are specific to Santa Fe County. The County will serve these properties via their own infrastructure up to the point of connection to the City's sanitary sewer collection system.

MWH, Global, Inc. performed a Cost of Service Analysis (see attached) in order to establish the wholesale rate. The sewer rates are made up of two components. The first is a monthly sewer service charge and the second is the monthly usage charge. The monthly sewer service charge is a fixed charge applied to each bill. The monthly sewer service charge includes utility billing costs, fifty three percent of administration costs, water testing costs, and fifty three percent of engineering costs. The monthly sewer usage charge includes treatment costs, forty seven percent of administration costs, sewer line maintenance costs, forty seven percent of engineering costs, industrial pretreatment program costs and bio-solids handling costs.

Three different scenarios were assumed in providing three separate options in determining wholesale rates. However scenario1 was found to be impractical since it creates a situation where the customers inside the city limits would be subsidizing the wholesale rate provided to the County and therefore was removed from consideration. In Scenario 1, the County would be charged only one monthly sewer service charge of \$6.45 and would not equitably share in the costs associated with the monthly service charge. Also, no sewer line maintenance and operation costs for line maintenance are included in this scenario.

The following are the scenarios considered in establishing the County Wholesale Sewer Rates:

Note: In both scenarios described below, the monthly sewer usage charge will be charged to the County based on the number of customers connected to the County System that will utilize City facilities for treatment. The residential and commercial customer usage will be determined in the same manner as all other City customers. The County will provide an itemized usage report to the City for billing purposes that shows all water reads and usages for each of its customers. This report will be used to by the City to bill the County.

Scenario 2 – The County will be charged a monthly service charge based on an accumulative sum of each of the County's individual customers. For example, if the County serves 676 customers via treatment by the City's system, the monthly service charge to the County would be calculated by multiplying 676 by \$4.30. This would result in a monthly service charge of \$2,906.80. No sewer line maintenance and operation costs are included in this scenario.

Scenario 3 – Is similar to Scenario 2 with the exception that the sewer line operations and maintenance costs for interceptor sewer lines are factored into the rate. An interceptor sewer is any line that has a diameter of 10 inches or greater. Interceptor sewer lines account for fourteen percent (14%) of the sewer system. Scenario 3 is the most equitable for the entire customer base since it incorporates some sewer line operation and maintenance into the wholesale rate.

The wholesale rates based on Scenario 3 are being recommended for the following reasons:

- Each unit being served will have a monthly sewer service fee that will be billed as a lump sum charge to the County. This will allow for the actual costs to be directly proportional to development growth.
- Sewer line operation and maintenance costs for interceptor sewers are incorporated into the rate structure.

The annual decrease in revenues for scenario 3 (based on 676 units) is \$9,320. As shown in table below, Scenario 3 has the least impact to annual revenues in comparison with the other two scenarios.

Although there will be a reduction in revenues under any of the three scenarios, there will also be some savings to the Utility Billing Division due the reduction in individual bills that need to be processed and managed. MWH, Global Inc. has begun the financial analysis that re-evaluates all sewer rates utilizing FY 2012/2013 audited financial information.

REQUESTED ACTION

The Wastewater Management Division recommends the approval of an ordinance relating to sewer rates for properties located outside the city limits; amending subsection 22-6.2 SFCC 1987 to establish that the Santa Fe County Housing Assistance Ordinance shall have jurisdiction over properties outside the city limits; and amending rule 8 a. of Exhibit A of Chapter 22 SFCC 1987, City of Santa Fe Sanitary Sewer Rate, Fee and Penalty Schedule, to establish customer wholesale rates for properties located outside the city limits that are connected to the city sewer system.

Wastewater Cost-of-Service

The City of Santa Fe Wastewater Division engaged MWH Global to prepare a wastewater Cost-of-service allocation study for FY2012-13. MWH presented the results of that study in October 2012. The memorandum summarizing the findings and results of that study is attached to this memorandum. Recently the City asked MWH to review the calculated rates for the customers that will be absorbed by Santa Fe County Which the City wastewater utility will provide wastewater treatment as a wholesale customer.

The County of Santa will absorb through annexation about 700 customers that the City of Santa Fe provided full retail services. The County will bill and maintain the collection system of these customers.

The rates developed in October 2012 included a monthly service charge and a volumetric rate per thousand gallons. The monthly service charge includes:

- Billing costs totaling \$754,755 included in the administrative Org 52251
- A 53% of the administrative costs of Org. 52251
- 100% of the costs of Org. 52254 Wastewater Department Wide
- 53% of costs of Org. 52456 Engineering & Environmental

The volumetric service rate per thousand gallons includes:

- Treatment costs Org. 52452
- Collection costs Org. 52455
- Pretreatment costs Org. 52458
- Compost costs Org 52460

We updated our COS calculations assuming three different scenarios:

- County customers will be bill as a one wholesale customer and will not share any of the collection costs. All the costs included in the service charge are the ones described above but the county will only share those costs as one single unit.
- In scenario 2 instead of assuming the County as one single customer for all the service charge
 costs we allocated the billing costs as one single unit but the other costs are allocated assuming
 the 676 customers the County absorbed. In this scenario the County does not share any
 collection costs.
- 3. Scenario 3 is the same as scenario 2 on the service charge. On the volumetric rate there is a portion of O&M collection costs allocated to them. The portion of the O&M collection costs (org. 52455) included are those related to the maintenance of lines 10" or greater. In this case we assumed that of the total O&M collection costs 14% is destined to the maintenance of lines 10" or greater.

The results of these three scenarios are presented in Table 1.

21	Section 1. Subsection 22-6.2 SFCC 1987 (being Ord. #1997-3, §39, as amended
22	is amended to read:
23	22-6.2 Properties Outside City Limits.
24	A. Purpose. The governing body has determined that connections to the city's sewer
25	system should be allowed outside the city limits under certain conditions. The wastewater

treatment plant has the capacity for such connections, the effluent is a benefit to the city, and protection of the groundwater is important.

B. Definitions. As used in this section:

Presumptive City Limits is defined in the settlement agreement and mutual release of claims entered into by the city of Santa Fe, Santa Fe County and other parties dated May 19, 2008.

- C. Connection Prohibited. Sanitary sewer service line connections and sanitary sewer mainline extensions are prohibited outside the presumptive city limits except as set forth in this section.
- D. Existing Agreements. Sanitary sewer service line connections and sanitary sewer mainline extensions for which there is a valid, written agreement obligating the city to allow connection to the city's sewer system shall be reviewed by the city attorney and may be implemented by the wastewater management division director.
- E. Property Owners. This section shall apply to properties owned by private property owners as well as to properties owned by county, state or federal agencies to the extent allowed by law.

F. Areas of Sanitary Sewer Service.

- (1) Requests for sanitary sewer service line connections and sanitary sewer mainline extensions submitted after October 29, 2008, (date of adoption of this Ordinance) for properties located entirely within the areas to be annexed, as defined in the settlement agreement and mutual release of claims entered into by the city of Santa Fe, Santa Fe county and other parties dated May 19, 2008, shall be processed in the same manner as requests for properties within the current city limits. This paragraph shall not apply to those requests described in paragraph D. above.
 - (2) Requests for sanitary sewer service line connections and sanitary sewer

mainline extensions for properties outside the presumptive city limits including the Aqua Fria traditional historic community and the county of Santa Fe fairgrounds shall be processed pursuant to paragraph I. below.

- G. Affordable Housing. [Section 14-8.11 (D) SFCC 1987 regarding the Santa Fe

 Homes Program] The Santa Fe County Housing Assistance Ordinance, Sec. 151.01, Santa Fe

 County Code of Ordinances shall apply.
- H. Conditions of Service. The property owner and all future owners of the property obtaining city sewer service under this section shall be required to pay all applicable rates, charges and fees for city sewer service. Requirements set forth in Chapters XIV and XXII SFCC 1987 and all other rules and regulations pertaining to the use of the city's sewer service are also a condition of service.

I. Water/Wastewater Review Team.

- (1) All applications for city sewer service connections for properties outside the presumptive city limits shall be reviewed by the water/wastewater review team (WWRT). The team shall meet regularly and shall be made up of city and county staff from the water division, the wastewater division, the city attorney's office, the county attorney's office, the land use departments and the office of affordable housing. The team shall evaluate the completeness of the application and the feasibility of implementing the connection. Applications shall include the following:
 - (a) A map of the proposed project in relation to the existing city limits and the presumptive city limits;
 - (b) A detailed description of the proposed development including the type and size of proposed land uses;
 - (c) The health, safety, public welfare or other legal reason for the connection;

- (d) Documentation from the county of Santa Fe that county sewer service is not available; and
- (e) A certified Santa Fe Homes Proposal as set forth in Section 14-8.11 SFCC 1987.
- (2) If the WWRT finds the connection feasible and the legal reasons compelling, it shall submit a report to the public utilities committee of the city, the governing body and the board of county commissioners for consideration of an agreement between the city of Santa Fe and Santa Fe county pursuant to Section 2.m. of the settlement agreement and mutual release of claims entered into by the city of Santa Fe, Santa Fe county and other parties dated May 19, 2008.
- J. Wastewater Service Agreement. The property owner obtaining city sewer service under paragraph F.(1) of this section shall enter into a wastewater service agreement with the city. The applicant shall agree to not oppose the annexation of the property upon the request of the city and in accordance with the applicable regulations regarding such annexations. The agreement shall be reviewed and approved by the city attorney's office and the wastewater management division director. The document, which includes a legal description of the property, shall apply to the property and all future owners and shall be recorded at the county clerk's office and retained at the city clerk's office. No connection to the city's sewer system shall be provided until a copy of the recorded document is provided to the wastewater management division director. The requirement to agree to not oppose the annexation of the property shall not apply to property located entirely within the boundary of the Agua Fria traditional historic community.
- Section 2. Rule 8 A. of Exhibit A of Chapter 22 SFCC 1987 (being Ord. #1997-3, Exhibit A, as amended) is amended to read:

 Single family residential sewer service fees and usage fees shall apply if

STATUS OF THE CITY'S CASH AND INVESTMENT PORTFOLIO AS OF SEPTEMBER 30, 2013. (HELENE HAUSMAN)

Helene Hausman presented information from her Memorandum of November 4, 2013, which is in the Committee packet. Please see this Memo for specifics of this presentation.

Ms. Hausman said she met with Washington Federal today and they seem interested in the possibility of a \$250,000 Certificate of Deposit, commenting they don't want to go any more than the FDIC insured right now. She said she thinks it was a positive meeting and we'll see where things go.

B. UPDATE OF PROPOSED GROSS RECEIPTS (HOLD HARMLESS REVENUE REPLACEMENT). (MARCOS TAPIA)

Marcos Tapia said these are scenarios we are examining with regard to the hold harmless, noting he will have a timeline for the City Manager to review. This looks to see what it would produce if it were to be enacted and what it would affect. He said he did another calculation if we just did 2/8, noting Las Cruces enacted the full increment. He said the LFC met on this and they are talking about bringing this up again in the next Legislative Session, because it was rushed and not well thought out on some areas. For example, Los Alamos County is a Class H City/County, so both would be hit with the 3/8. He said Corrales would make money off this, potentially 10 times the amount.

Chair Dominguez said then there will be changes by the Legislature, but we don't know what those will be.

Mr. Tapia said this is correct, but he doesn't think they will pull the whole thing. However, he believes they will correct what they already have.

Chair Dominguez asked how does the Hold Harmless work.

Mr. Tapia said it is by percentage, starting at 94%, pro-rated over the next 15 years, until we get nothing. He said the first year we will lose about \$630,000. It will be a little less each month.
