The aggregate amount of seed money contributions from any one contributor shall not exceed one hundred dollars (\$100), and the aggregate amount of seed money contributions accepted by a candidate shall not exceed ten percent (10%) of the amount payable under 9-3.10 SFCC 1987 to a candidate in a contested election for the office sought.

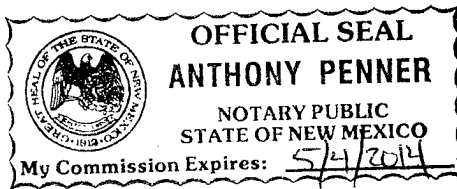
