

Physical Demands/Work Environment

Work is performed outdoors under inclement weather conditions at any time of the day or night, and irregular and extended hours may be required. This position is routinely exposed to loud noises, vibration, fumes, odors, dust, infectious agents (germs, viruses, bacteria, etc.) and is subject to minor injuries such as cuts, scrapes, bruises, animal or insect bites, allergens, pesticides, herbicides, gases, fumes and sprays. This position requires the ability to lift and/or move, lift and carry 50 pounds and perform strenuous work involving bending, twisting, reaching, lifting, climbing, squatting, and rapid movement. Specific vision abilities required by this job include: close vision, distance vision, color vision, peripheral vision, and depth perception. The ability to hear and speak is required. Weekend, holiday, night and shift work may be required.
