GENERAL DESCRIPTION

Under general supervision, this position is responsible for inspection, maintenance, and repair of the distribution and transmission facilities in the Sangre De Cristo Water Division.

NATURE OF WORK

Essential Functions: The list of essential functions, as outlined herein, is intended to be representative of the tasks performed within this classification. It is not necessarily descriptive of any one position in the class. The omission of an essential function does not preclude management from assigning duties not listed herein if such functions are a logical assignment to the position.

- Directs apprentices, skilled, and semi-skilled workers in performing a variety of duties by servicing customer water work orders, installing water lines and equipment, including the maintenance and repair of all facilities in the transmission and distribution system.
- Responsible for adhering to all Safety policies, and/or regulations established by the City in the performance of daily duties. Instructs personnel in
 the proper and safe way to perform their duties and in the use of tools and equipment. Provides safety training instructions and is responsible for
 the general safety of personnel.
- Prepares assemblies for installation, replaces worn parts, performs cutting, threading, and pipefitting. Installs and tests pressure valves and
 pressure gauges and meters in connection with high-pressure water systems.
- Directs the installation of protective barricades and flares on street openings, barricades or directs the reinforcement of ditches to prevent cave-ins, determines pipe location for new services, and installs and pressure checks water service meters.
- Performs the necessary "laying out" and grading for water lines preparatory to installation and connection of all types of water equipment needed for new construction, modification, and repairs; lays water mains and laterals; taps water mains; and lays services lines to buildings, etc.
- Receives troubleshooting, major repair, and installation work orders, responsible for coordinating job through completion.
- Conducts water experiments and applies chemicals to system as required including the taking of system water samples as required.
- Performs scheduled inspection of piping, valves, fittings, and auxiliary equipment of water system for defects. Repairs damaged sections or fabricates replacements following specification on defective parts.
- Inspects and analyzes defects or malfunction in water systems to facilitate repairs, including piping and all auxiliary equipment.
- Prepares field maps and maintains records and, makes reports to supervisor regarding unusual or serious situations.
- Operates a variety of motorized heavy equipment.
- Inspects fire hydrants and repairs as necessary.

- Must pass a drug and/or alcohol test prior to employment and submit to periodic drug and/or alcohol testing thereafter.
- Employee may be called out in emergency situations. When contacted, the employee is expected to report to work unless there are special non-recurring circumstances.

Knowledge of arithmetic

Ability to learn occupational hazards and safety procedures in water operations/maintenance field; operate powered, pneumatic and manual equipment machinery and tools used in water field/plant operations; ability to establish effective working relationships; read and write, and understand and follow oral and written instructions; observe and adhere to safety rules and established regulations and guidelines; operate a Dump Truck, City utility vehicle, tamper, jack-hammer, plate tamper, power cutting saws, boring machine, pipe wrenches and other standard hand tools, multi-line telephone, digital/cellular telephone, and two-way radio.

PHYSICAL DEMANDS/WORK ENVIRONMENT

Work is performed primarily outdoors, sometimes in inclement weather and in a field environment; incumbents are exposed to loud noises, vibrations, chemicals, toxic gases and fumes, allergens, is exposed to the possibility of cuts, bruises, scrapes, broken bones, burns, germs, and bacteria. Irregular working hours, the employee may be called out in emergency situations, in the area of regular assignment. May also, under extreme emergency situations, be called out to assist in other areas of the Water Services Division. Work is strenuous, requiring walking, standing, lifting up to 100 lbs., carrying, bending, stooping, kneeling, crouching, reaching, handling, speaking, hearing, good visual acuity including color, close, distance, peripheral, and depth perception.
