The deadline for receipt of proposal has been extended to **January 11, 2018 at 2:00 pm**.

Listed below are the questions that have been raised concerning the aforementioned bid.

Question 1:

On the bid under Section 3 the following is stated:

"Samples: The following items shall be submitted with your bid submittal if items are not received your bid will be disqualified...." - this is preceded by a list of 13 specific items. <u>All 13</u> items indicated are required.

The following section 4 states the following in regard to samples "Samples of all items proposed shall be available for inspection upon request by the Santa Fe Police Department and/or the Procurement Department. Sample Uniforms are not required with the proposal; however, samples may be requested at any time during proposal evaluation and they shall be provided within five (5) days of the request."

Can we get clarification as to whether samples are in fact required at time of bid or will be requested after bid submittal? Is it just the 13 list of items required at bid submittal? All 13 items indicated are required.

Question 2:

Under section 4 in regards to emblems and insignia samples the following is stated:

"A sample of all emblems and/or insignia as per specifications (Attachment A) shall be provided with the proposal. Proposals received without emblems and/or insignia may not be considered for the award."

There is no "ATTACHMENT A" on the bid that has the emblem or insignia specifications attached to the bid documents. Attachment 20171221114641 dept. embroidered logo and officers name on right chest; Attachment 20171221111159 shoulder patch size and pic

Can we get a copy of the "Attachment A" so that proper emblem/insignia samples can be supplied with our bid response? The above is suffice for the bid response or submittal of the 13 items/samples.

Question 3:

Under the section titled "EXCEPTIONS TO SPECIFICATIONS"

It asks for specifications to be supplied for all items. Can you clarify if this is for ONLY the items that are being substituted or have "exceptions" or for all 200+ items listed on the bid? **All items listed.**
