On November 1st 2004, The City of Santa ("Santa Fe Trails") conducted an extensive Intelligent Transportation Systems ("ITS") needs analysis and concluded it was a necessity for the agency to procure demand response transportation management scheduling / dispatching software, and support and maintenance services for that software. Santa Fe Trails conducted a competitive procurement which included researching numerous firms, receiving product demonstrations, conducting on-site tours of active systems, and receiving price comparisons and formal solicitation responses. Routematch Software, Inc. ("Routematch") was selected as the most competitive responsive vendor. Routematch was awarded a contract that provided the City of Santa Fe with:

(1) Routematch Demand Software ("Software"); (2) tablet computers; (3) professional services to implement the foregoing; and (4) support and maintenance services for the Software. Routematch has provided Software support and maintenance since the inception of this contract.

After Santa Fe Trail's adoption of the Routematch Software paratransit ITS, we conducted an operational analysis of our fixed route system and evaluation of our overall system. On April 1st, 2012, The City of Santa Fe then determined that the integration of the Routematch Software with our fixed route system would provide even greater operational and staff efficiencies, real-time fleet awareness, and overall enhanced customer service.

Sole Source Justification Letter:

On November 1st 2004, The City of Santa ("Santa Fe Trails") conducted an extensive Intelligent Transportation Systems ("ITS") needs analysis and concluded it was a necessity for the agency to procure demand response transportation management scheduling / dispatching software, and support and maintenance services for that software. Santa Fe Trails conducted a competitive procurement which included researching numerous firms, receiving product demonstrations, conducting on-site tours of active systems, and receiving price comparisons and formal solicitation responses. Routematch Software, Inc. ("Routematch") was selected as the most competitive responsive vendor. Routematch was awarded a contract that provided the City of Santa Fe with:

(1) Routematch Demand Software ("**Software**"); (2) tablet computers; (3) professional services to implement the foregoing; and (4) support and maintenance services for the Software. Routematch has provided Software support and maintenance since the inception of this contract.

After Santa Fe Trail's adoption of the Routematch Software paratransit ITS, we conducted an operational analysis of our fixed route system and evaluation of our overall system. On April 1st, 2012, The City of Santa Fe then determined that the integration of the Routematch Software with our fixed route system would provide even greater operational and staff efficiencies, real-time fleet awareness, and overall enhanced customer service.

The Federal Transit Administration's 2016 Best Practices Procurement and Lessons Learned Manual, provides that the keeping Routematch's ITS solution and scheduling software is in The City Santa Fe's best interest for several, essential reasons, including: (1) Unique service – Routematch has proven to be a reliable partner for Santa Fe since the inception of the contract in 2004. Future upgrades and enhancements the city is looking to implement already integrate with the Routematch Software, unlike other providers in the market that are not capable of integrating with the ITS; (2) Substantial Duplication – The City of Santa Fe will enjoy cost savings by adding new products / enhancements to a product which needs no additional development to integrate with the existing Routematch Software; and (3) Unacceptable Delay in Deployment – Santa Fe Trails should avoid any such delays due to Routematch's familiarity with the Product and the knowledge on how to support and maintain the product and the proven success of

- GIS Mapping Data.
- Technical Support and Maintenance.
- Minimize service disruptions and time spent drafting, evaluating and transitioning through a formal procurement process.
- Minimize implementation costs of transitioning to a new system.
- Scalability to add future functionalities that we may look to integrate into our existing system.
