The following questions were asked:

**Question #1:** Is there a difference from "Brush Removal - 100% Ground Cover" and "Clear and Grubbing" or should we treat them as the same task?

Answer #1: Brush removal will have identified or tagged items where as "clear and grubbing" Is not selective.

**Question #2**: Under item, "Chipping" there are 2 units listed, is that a typo or are you asking for a price to chip two items?

Answer #2: Yes, this is a typo the unit should be listed as 1.

**Question #3:** Is "Establishment Watering - Seeding" scope for one watering or the watering needed for the whole establishment period?

Answer #3: Water need for the entire establishment period. This will be determined during the task assignment. It is assumed that the first watering is included in the cost.

**Question #4:** Under item "Green Waste Tipping Fee" what size of a load are you looking for pricing on, an 8' pick-up truck bed? 16' trailer with 4' sides?

Answer #4: The City of Santa Fe Transfer Station charges by the ton. The amount is prorated accordingly. This would be for both green and general waste. If the contractor has another method of disposal, it should be identified. Please include the loading and unloading in your cost submittal.

**Question #5:** For item "Re-vegetation Seeding" in Addendum 1 you mention the seed mix will be determined on a case-by-case basis but do you have a general PLS pound per acre to base the pricing on.

Answer #5: No, but your base price can be specified and listed.

Question #6: Since the City of SF is now managing the parks organically and the spraying would be IPM approved does the spraying need to be done by a licensed applicator or arborist since they will not be applying chemical pesticides and herbicides?

Answer #6: Technically, we can apply sprays but this must meet the City's IPM requirements. We are currently managing lands to avoid chemical spraying. If the city requested spraying, the contractor would need to ensure the person applying spray is a license professional.

**Questions #7:** Are there any scopes of work that need a special license to perform the any of these scopes of work?

Answer #7 See addendum #1-question. The contractor is responsible to possess the relevant license for the work described in each task order

**Question #8:** Can the bid company provide their own bid forms? **Answer #8:** Yes, if the contractor make their own bid form or uses a firm's surety form it must align with the cities for comparison purposes.
